ORDER:-

During demand grant for Highways and Minor Ports 2018 – 19 held on 11.06.2018, the Hon'ble Chief Minister made an announcement among others, for the preparation of Detailed Project Report for formation of By-pass to Rasipuram town in Namakkal District.

2. In his letter read above, the Chief Engineer (Projects), Highways Department, has stated that the work of Forming By-pass to Rasipuram town Phase-II is a long felt need of the public to reduce the traffic congestion. The proposed Rasipuram By-Pass – Phase-II branches from Thanneerpandal kadu at Km 30/6 of Malliyakkarai – Rasipuram – Trichengode – Erode road (State Highways-79) and joins at Km 52/4 of Mohanur – Namakkal – Sendamangalam – Rasipuram road (State Highways-95) Km 0/0 – 11/2. The total length of this By-pass is 11.20 Km. The villages which will be benefitted by this By-pass are Thanneerpandal Kadu, Ariyanguandanpatti, Kuruwalla, Pachudayampalayam, Thoppapatti, Jedarpalayam, Annamarkovil, Kumananaikanur, Bodinaikanpatti and Appanaikanpatti and population benefitted will be more than 50,000.

3. The Chief Engineer (Projects), Highways Department has therefore requested the Government to accord Administrative Sanction for a sum of Rs.40.00 Lakhs for the preparation of Detailed Project Report for Forming By-pass to Rasipuram Town Phase-II starts from km 30/6 of Malliyakkarai – Rasipuram – Tiruchengode – Erode road (State Highways-79) and ends at km 52/4 of Mohanur – Namakkal – Sendamangalam - Rasipuram road (State Highways-95).

4. The Government after careful examination accept the proposal of the Chief Engineer (Projects), Highways Department and accord Administrative Sanction for a sum of Rs.38,97,000/- (Rupees Thirty eight lakhs ninety seven thousand only) for the preparation of Detailed Project Report for Forming By-pass to Rasipuram Town Phase-II starting from km 30/6 of Malliyakkarai – Rasipuram – Tiruchengode – Erode road (State Highways-79) and ends at km 52/4 of Mohanur – Namakkal – Sendamangalam - Rasipuram road (State Highways-95)

5. The expenditure sanctioned in para-4 above shall be debited to the following head of account:-

5054 Capital outlay on Roads and Bridges – 80.General – 004.Research and Development - State's Expenditure – AA.Investigation / Estimation of Project work under Roads and Bridges -16.Major Works


