ORDER:-

During the Budget demand 2018-2019 for Highways and Minor Ports Department, the Hon'ble Chief Minister made the following announcement.

“மாநகரங்களில் ஏற்படும் போக்குவரத்து நெரிசலை குறைக்கும் பொருட்டு, கடலூர் மாவட்டம், திட்டக்குடி, பெரம்பலூர் நகரம், நாமக்கல் மாவட்டம் இராசிபுரம், நீலகிரி மாவட்டம் உதகை மற்றும் குன்னூர், கோயம்புத்தூர் மாவட்டம் காரமடை, தஞ்சாவூர் மாவட்டம் பட்டுக்கோட்டை, தூத்துக்குடி மாவட்டம் சாத்தான்குளம், விருதுநகரில் மாநில நெடுஞ்சாலை 41-ல் இணைப்புச் சாலை, திண்டுக்கல் மாவட்டம் வத்தலக்குண்டு ஆகிய நகரங்களில் புறவழிச்சாலை அமைக்க விரிவான திட்ட அறிக்கை ரூ.4.68 கோடியில் தயாரிக்கப்படும்”.

2. The Chief Engineer (Projects) Highways who was addressed in this regard has since stated that the proposed new formation of ring road starts at Km 43/2 of SH-29 (Thanjavur - Pattukottai - Sayalkudi Road) and ends at Km 51/10 of Pattukottai – Muthupet Road for a length of 14.40km. This road lies in Pattukottai Assembly constituency and Thanjavur Parliamentary constituency. Pattukottai is an important town with population of more than 3,76,236. The importance of the town is agriculture, especially Coconut farming and other coconut allied products. Some of the important tourism places like Manora fort & Muthupet Alaiyathi Forest are located around Pattukkottai. Many important hindu temples such as Sri Puradhana Vaneshwarar temple, Nadiyamman Devi temple are located in this town. Many Schools, Colleges and an agricultural university is located in this town. The East Coast Road plying adjacent to Pattukottai town, provides connectivity to Nagoor, Nagapattinam & Tuticorin. The people from Thanjavur, Kumbakonam, Tiruvarur,

Mannargudi, Muthupettai, Athirampattinam, Nagore, Vedaranyam have to cross Pattukottai Town to reach Southern and Western regions of Tamil Nadu. Besides the Municipal and highways roads in Pattukottai, the town is heavily congested due to the vehicular flow and commuting population for the sake of market oriented activities.

3. The Chief Engineer (Projects) Highways has therefore requested the Government to accord administrative sanction for a sum of Rs.39.00 lakhs for preparation of detailed project report for the work of "Formation of Ring road to Pattukottai Town from Km 7/4 - 21/8."

4. The Government after careful examination, accept the proposal of Chief Engineer (Projects) Highways Department and accord administrative sanction for an amount of Rs.30,00,000/- (Rupees thirty lakh only) for preparation of detailed Project Report for the work of "Formation of Ring road (Third phase of Bypass) to Pattukottai Town from Km 7/4-21/8".

5. The expenditure sanctioned in para 4 above shall be debited to the following Head of account:-
