## ORDER

Among others, the Hon'ble Chief Minister of Tamil Nadu has made the following Announcement in the floor of Assembly, during the demand of Highways and Minor Ports Department under Announcement 2017 - 18 for developing the Highways infrastructure and providing a better connectivity on 28-06-2017.

2. In the letter read above, the Chief Engineer (Metro), Highways Department has stated that based on the above announcement Detailed Project Report (DPR) has to be prepared for the following 6 works for early execution.

3. The Chief Engineer (Metro), Highways Department has further stated that the above said works are very essential due to the following reasons:-

- i. Due to heavy traffic congestion at major junctions located in urban areas, this has to be resolved at once by providing Grade Separators.
- ii. Preparation of Detailed Project Report for Grade Separator works at major junctions covering Mugalivakkam, Ramapuram, L&T, DLF and extension of Vadapalani Grade Separator upto Ashok Pillar requires more than 9 months. Hence it has to be taken up early.

4. The Chief Engineer (Metro), Highways Department has therefore requested the Government to accord Administrative Sanction for an amount of Rs.3.48 crore to proceed with preparation of Detailed Project Report for 6 works mentioned above.

5. The Government after careful examination on the proposal of the Chief Engineer (Metro), Highways Department have decided to accept the same. Accordingly, the Government sanction a sum of Rs. 3.48 crore (Rupees three crore forty eight lakhs only) from the revolving fund maintained by the Chief Engineer (Construction and Maintenance), Highways Department to proceed for preparing the Detailed Project Report for the six works mentioned in the para 2 above.

6. The expenditure sanctioned in para 5 above shall be debited to the following Head of Account.

5054-Capital Outlay on Roads and Bridges – 80 General -004 – Research and Development - State's Expenditure – AA- Investigation/ Estimation of Project work under Roads and Bridges-16 major works.
