ORDER:-

In Government order first read above, among others Government accorded administrative sanction for an amount of Rs.35.47 Lakh for the preparation of Detailed Project Report for the work of "Construction of Road Over Bridge in lieu of existing Level Crossing No.74 at Km 90/10 of Cheyyur –Vandavasi – Polur road at Railway Km 94/22-24 in between Pakkam and Acharapakkam Railway Stations" under Railway Works Programme 2018-2019 on cost sharing basis with Southern Railways.

2. In the letter second read above, the Chief Engineer (Projects), Highways Department has stated that, the level Crossing is located at Km 23/2 of Cheyyur – Vandavasi – Polur road. This Road is classified as State Highway (SH-115). The existing level crossing is located at 263m from NH45 Road Junction. The existing Level Crossing is Manned Level Crossing with two Broad gauge lines are passing. The Level Crossing is situated at Railway Km 94/22 – 24 in between Pakkam and Acharapakkam Railway stations in the Chennai– Vilupuram Railway line. The people living nearby using this road to go to the Vandavasi, Melmaravatur, Cheyyur, Chithamur, colleges, schools, hospitals. This road meets NH 45 at Sothupakkam, Which is very near to Melmaravathur Temple. The alignment of the proposed Road Over Bridge has been

approved by the alignment committee on 12.11.2019. An extend of 7604 Sq.m of patta private dry classification lands and 5300 Sq.m of Government poramboke lands are absolutely required for construction of this road over bridge in Sothupakkam and Poraiyur village.

- 3. The intensity of traffic at the Level Crossing is 104498 (August 2015) which is more than 1,00,000 Train Vehicle Unit warrants construction of Road Over Bridge. This work involves more Land Acquisition for construction of Road Over Bridge. Land Acquisition including compensation for land, Structural Valuation and Tree Valuation, etc., Necessary compensation for acquiring lands, structures, trees any other assets attached have to be paid for project affected person as per latest prevailing Land Acquisition rules and acts. Accordingly, the Land Acquisition estimate has been prepared tentatively for an amount of Rs.15.37 Crore for payment towards compensation as per latest rules in force.
- 4. The Chief Engineer (Projects), Highways Department has therefore requested the Government to accord Administrative Sanction for Land Acquisition of 7604 sq.m for the work of "Construction of Road Over Bridge in Lieu of existing Level Crossing No.74 at Km 23/2 of Cheyyur— Vandavasi Polur Road at Railway Km 94/22-24 in between Pakkam and Acharapakkam Railway Stations" for an amount of Rs.15.37 Crore.
- 5. The Government after careful examination accept the proposal of the Chief Engineer (Projects), Highways Department and accord administrative sanction for Land Acquisition of 7604 Sq.m. for the work of "Construction of Road Over Bridge in lieu of existing Level Crossing No.74 at Km 23/2 of Cheyyur –Vandavasi Polur road at Railway Km 94/22-24 in between Pakkam and Acharapakkam Railway Stations" for an amount of Rs.15.37 Crore (Rupees Fifteen Crore and Thirty Seven Lakh Only).
- 6. The expenditure sanctioned in para-5 above shall be debited under the following head of account:-

5054 Capital Outlay on Roads and Bridges - 03. State Highways - 101. Bridges - State's Expenditure - JG Construction of over and under bridges in lieu of existing level crossings - 464. Lands - 01. Lands - Voted.

- 7. The expenditure sanctioned in Para-5 above is an item of "New Instrument of Service" and the approval of the Legislature will be obtained in due course. The Chief Engineer (Projects), Highways Department is directed to send a draft explanatory notes for inclusion of the above expenditure in the Supplementary Estimates 2020-21 to Finance (BG-I/PW-I) Department without fail.
- 8. The Chief Engineer (Projects), Highways Department is authorized to incur the expenditure sanctioned in para 5 above.
