### **ORDER:**

In the Government Order first read above, orders were issued for Constituting the Board of Directors of Tamil Nadu Road Infrastructure Development Corporation by including an officer in the Grade/Rank of Chief Engineer (outsourced) as Executive Director.

2) In the Government Order second read above, orders were issued appointing Thiru.V.S.Thangavel, Chief Engineer (Highways) (Retired) as Executive Director, in Tamil Nadu Road Infrastructure Development Corporation for a period of one year from the date of joining his duty for a consolidated remuneration of Rs.67,000/- per month.

3) In the Government Order third read above, orders were issued for extending the services of Thiru.V.S.Thangavel, Executive Director, Tamil Nadu Road Infrastructure Development Corporation for a period of one year from 09.03.2019 to 08.03.2020.

4) The Chairman and Managing Director, Tamil Nadu Road Infrastructure Development Corporation in his letter 4<sup>th</sup> read above has stated that the period of extension of Thiru.V.S.Thangavel, Executive Director expires on 08.03.2020 and has requested extension of his tenure for another year from 09.03.2020 and also to accord permission to continue to hold the post of Executive Director for three months period with effect from 09.03.2020 as per the existing terms and conditions in anticipation of ratification and approval of continuance of service for one year with effect from 09.03.2020 as resolved by the board in its resolution CR.No.1/BDM/2020, dated.05.03.2020.
