ORDER

During Dr.MGR's Birth Centenary celebration at Salem on 30.09.2017, the Hon'ble Chief Minister made the following announcement:

"A bypass with a length of 11 Kms from Thandavarayapuram in Attur bypass to Gandhipuram will be taken up"

- 2) The Chief Engineer (Construction and Maintenance) Highways Department in his letter read above has stated that the proposed bypass to Attur town starts at Km 88/8 of Musiri-Thuraiyur-Attur road-SH-30 near Thandavarayapuram and ends at Km 59/2 of Salem-Ulundurpet road-NH-79 hear Gandhipuram to a length of 11.00 Km. The Salem-Ulundurpet road (NH 70) Attur-Perambalur road (NH 136) and Musiri-Thuraiyur-Attur road (SH-30) runs through the Attur built-up area. There is an existing bypass to Attur town on Northern side which is formed by the NHAI. To avoid the traffic congestion and accidents in Attur town, it is necessary to provide a bypass to Attur town on Southern side between Gandhipuram to Thandavarayapuram. The proposed bypass runs through Narasingapuram, Attur Municipality, Valayamadevi village and Ammampalayam village (Gandhipuram)
- 3) The Chief Engineer (Construction & Maintenance) Highways Department has therefore requested the Government to accord administrative sanction for a sum of Rs.10.00 lakhs for the work of "Engaging Consultancy services for the preparation of

Alignment, Land Plan Schedule and the proposal for the Land Acquisition for formation of Attur bypass (Phase-I)

- 4) The Government after careful examination, accept the proposal of the Chief Engineer (Construction & Maintenance) Highways Department and accord administrative sanction for a sum of Rs.10,00,000/- (Rupees Ten lakh only) for Engaging Consultancy services for the preparation of Alignment, Land Plan Schedule and the proposal for the Land Acquisition for formation of Attur bypass (Phase-I)
- 5) The expenditure sanctioned in Para-4 shall be debited to the following head of account:-

"5054-Capital Outlay on Roads and Bridges-80-General-004-Research and Development- State's Expenditure - AA Investigation/Estimation of project work under Roads and Bridges.16 Major works"
