ORDER:-

Based on the Announcement made by the Hon'ble Chief Minister in the floor of Assembly on 11.06.2018, 15.07.2019 and 18.03.2020, the Chief Engineer (NABARD and Rural Roads), Highways Department had furnished the proposals for Construction/Reconstruction of Bridges to Government to forward the same to NABARD for its concurrence through Finance Department.

2. The Government forwarded the proposals for Construction / Reconstruction of 46 Bridges for Rs.147.29 Crore, 1 Bridge for Rs.7.28 Crore, 51 Bridges for Rs. 278.80 Crore, 1 Bridge for Rs.17.70 Crore and 15 Bridges for Rs.55.80 Crore to NABARD for its concurrence under NABARD Loan Assistance Schemes on various dates.

- 3. After obtaining the concurrence from NABARD, the Government have issued orders, according Administrative Sanction under NABARD Loan Assistance at 80:20 ratio, vide Government Orders first, second, third, fourth and fifth read above.
- 4. In the letter sixth read above, the Chief Engineer, (NABARD and Rural Roads), Highways Department has furnished the proposal, as instructed by the Chief Secretary to Government during the High Power Committee Meeting and requested the Government to accord Administration Sanction for 22 bridge works at a cost of Rs.12188.24 lakh for which the concurrence from NABARD was awaited.
- 5. In the letter seventh read above, the General Manager, NABARD has informed that Internal Sanctioning Committee (ISC) in its 75th meeting held on 16th December 2020 has sanctioned an amount of Rs.7630.61 lakh as RIDF XXVI loan out of the total financial outlay of Rs.9538.25 lakh to Government of Tamil Nadu, for 21 bridge works out of 22 works (except the work of Reconstruction of High Level Bridge at Km 0/2 0/6 of Ambalore Eklaspuram road across palar river).
- 6. The Government after careful examination, accept the proposal of the Chief Engineer (NABARD & Rural Roads), Highways Department based on the concurrence given by NABARD and accord Administrative Sanction for the Construction / Reconstruction of 21 Bridge works as against 22 Bridge works annexed to this order located in Major District Roads / Other District Roads / Panchayat and Panchayat Union Roads / Village Roads at a total cost of Rs.9538.25 lakh (Rupees Ninety Five Crore Thirty Eight Lakh and Twenty Five Thousand Only) in which Rs.7630.61 lakh as RIDF XXVI of NABARD loan assistance for the year 2020 2021 and Rs.1,907.64 lakh as State Share at 80:20 ratio and also accord Financial Sanction for a sum of Rs.50,00,000/- (Rupees Fifty Lakhs Only) for the Financial Year 2020 2021.
- 7. The expenditure sanctioned in para 6 above shall be debited to the following head of account.

"5054-Capital Outlay on Roads and Bridges-04 District and Other Roads-337 Road Works-State's Expenditure-JZ Construction / Reconstruction of Bridges with Loan Assistance from NABARD – 416 Major Works – 01. Major Works"

- 8. The Chief Engineer (NABARD and Rural Roads), Highways Department is authorized to incur the expenditure sanctioned in para 6 above.
- 9. The expenditure sanctioned in Para 6 above shall constitute an item of "New Instrument of Service" and approval of the Legislature will be obtained in due course. Pending approval of the Legislature, the expenditure will be initially met by an advance from the Contingency Fund. The Chief Engineer (NABARD and Rural Roads), Highways Department is directed to calculate the actual amount required for the period upto next supplementary estimates and apply for sanction of the same as advance from the Contingency Fund to Finance (B.G-I) Department directly in Form 'A' appended to the Tamil Nadu Contingency Fund Rules, 1963 along with a copy of this order. Orders

for sanction of an advance from the Contingency Fund will be issued from Finance (B.G-I) Department. The Chief Engineer (NABARD and Rural Roads), Highways Department is also directed to send a draft explanatory notes for inclusion the above expenditure in the Supplementary Estimates 2020-2021 to Finance (PW-I / BG-I) Department without fail.

10. This order issues with the concurrence of Finance Department vide its U.O. No.27 / DS (SA) / PW-I / 2021, dated 04.02.2021 and ASL No.1639 (One Thousand Six Hundred and Thirty Nine).
