ORDER:

In the Government order first read above, orders were issued for formation of Project Implementation Unit and Field Implementation Unit with 295 posts for Chennai-Kanyakumari Industrial Corridor Project which includes 5 numbers of posts under the cadre of Superintendent and 5 numbers of posts under the cadre of Assistant in the Head Quarters of Project Implementation Unit.

2. The Project Director (FAC), Chennai-Kanyakumari Industrial Corridor Project in his letter second read above has stated that, for effective functioning of the unit, the posts of Audit Superintendent and Audit Assistants are necessary. Hence, he has requested that one post of superintendent and one post of assistant under the ministerial strength may be converted into the post of Audit Superintendent and Audit Assistant without changing the overall strength sanctioned already and conversion of cadres as above would involve a meagre Additional Financial Implication of Rs.720/- per annum attributed due to special pay for the post of audit assistant (Rs. 60 per month) which can be met very well within the sanctioned provisions and there will not be any Additional Financial Implication to the Government and therefore requested the Government to issue necessary amendment to Government Order 1st read above for conversion of one post of superintendent to Audit Superintendent and one Post of Assistant to Audit Assistant to facilitate effective functioning of PIU, Chennai-Kanyakumari Industrial Corridor Project .

3. The Government after careful examination, have accepted the proposal of the Project Director (FAC), Chennai-Kanyakumari Industrial Corridor Project,

Highways Department and to issue the following amendment to the Government Order first read above as follows:-
