ORDER:

In the Government Order first read above, Administrative Sanction was accorded for the work of "Construction of Road Over Bridge at Km 3/0 of Goodanagaram - Anakanallur road in lieu of existing Level Crossing No.67 at Railway Km 160/2-4 in between Melalathur and Valathur Railway stations" under Railway Works Programme 2015-16 on 50:50 cost sharing basis for Rs.25.52 Lakhs towards preparation of Detailed Project Report.

2. In the Government Order second read above, the Government has accorded Administrative Sanction for carrying out land acquisition process for a sum of Rs.178.00 Lakhs.

- 3. In the letter fourth read above, the Chief Engineer (H), Projects has stated that the above work has been announced by the Hon'ble Minister for Public Works, Highways & Minor Ports Department during Budget demand for the year 2022-23. The alignment for the above work was approved by the alignment Committee on 19.05.2015. The Railway GAD has been approved on 02.09.2015. The Chief Engineer (H), Planning, Designs and Investigation has sent the detailed quantity estimate and structural drawings based on the Approved Railway GAD.
- 4. The Chief Engineer (H), Projects has furnished the Technical details of the proposed Road over Bridge as mentioned below:-

- 6. The Chief Engineer (H), Projects has therefore requested the Government to accord Administrative sanction for the work of, "Construction of Road Over Bridge at Km 3/0 of Goodanagaram Anakanallur road in lieu of existing Level Crossing No.67 at Railway Km 160/2-4 in between Melalathur and Valathur Railway stations" for an amount of Rs.37.40 Crores [Rupees Thirty Seven Crores Forty Lakhs only].
- 7. The Government, after careful examination, accept the proposal of the Chief Engineer (H), Projects and accord Administrative Sanction for an amount of Rs.35,99,84,288/- (Rupees thirty five crore ninety nine lakh eighty four thousand two hundred and eighty eight only) for the work of "Construction of Road Over Bridge at Km 3/0 of Goodanagaram Anakanallur road in lieu of existing Level Crossing No.67 at Railway Km 160/2-4 in between Melalathur and Valathur Railway stations" and accord financial sanction for a sum of Rs.10,00,000/- (Rupees Ten lakh only) for the current financial year 2022-23. The balance amount will be released in the subsequent financial years based on the requirement.
- 8. The expenditure sanctioned in para 7 above shall be debited under the following head of account:-

5054 Capital Outlay on Roads and Bridges – 03 State Highways-101.Bridges – JG Construction of over and under bridges in lieu of existing level crossings –416-Major Works-01 Major works.

9. The expenditure sanctioned in Para 7 above shall constitute an item of "New Instrument of Service" and approval of the Legislature will be obtained in due course. Pending approval of the Legislature, the expenditure will be initially met by an advance from the Contingency Fund. The Chief Engineer (Projects), Highways Department is directed to calculate the actual amount required for the period upto next Supplementary Estimates and apply for sanction of the same as advance from the Contingency Fund to Finance (B.G-I) Department directly in Form 'A' appended to the Tamil Nadu Contingency Fund Rules, 1963 along with a copy of this order. Orders for sanction of an advance from the Contingency Fund will be issued from Finance (B.G-I) Department. The Chief Engineer (Projects), Highways Department is also directed to send a draft explanatory notes for inclusion the above expenditure in the Supplementary Estimates 2022-2023 to Finance (BG-I/PW-I) Department without fail.
