ORDER:

In the Government order first read above, Government accorded sanction for a sum of Rs.42,613/- to Thiru. M.Venugopal, Additional Government Pleader (CS) towards 50% of total regulation fees for his appearance in O.P.No.663 of 2011 and Rs.14,204/- to Tmt. Saraswathi Sivaraman Iyer (CS) Government Advocate, who assisted the above Additional Government Pleader in this case.

- 2. The Project Director, Tamil Nadu Road Sector Project in his letter second read above has reported that, O.P.No.663/2011 had been filed in the Hon'ble High Court of Madras to set aside the Arbitration Award dated 11.05.2011 in respect of disputes 4 and 5 of Contract TNRSP 01. Pursuant to amicable settlement of disputes in Contract TNRSP 01, the PIU has requested the Special Government Pleader (CS), High Court of Madras to make necessary arrangements to withdraw the O.P.No.663 of 2011 filed in the Hon'ble High Court of Madras. Accordingly, Thiru.M.Venugopal, Special Government Pleader (CS), High Court of Madras had filed the memo petitions in the Hon'ble High Court of Madras to dismiss the O.P.No.663 of 2011 as withdrawn. The Hon'ble High Court of Madras had passed a Common order dated 11.11.2013 in O.P.Nos.156 and 663 of 2011 and dismissed the cases and requested the Government to sanction the balance 50% of the fees of Rs.42,613/- to Thiru. M.Venugopal Special Government Pleader (CS) for his services rendered in the O.P.No.663/2011 and Rs.14,204/- to Tmt. M.Jayasree, Government Advocate who assisted the above Special Government Pleader (CS) in this case.
- 4. The Government after careful consideration, accept the request of the Project Director, Tamil Nadu Road Sector Project- II. Sanction is accorded to a sum of Rs.42,613/- (Rupees Forty two thousand six hundred and thirteen only) the balance 50% of total regulation fees to Thiru.M.Venugopal, Special Government

Pleader (CS) for his services rendered in O.P.No.663 of 2011 and Rs.14,204/-(Rupees Fourteen thousand two hundred and four only) 1/3 of the fees of the Special Government Pleader (CS) to Tmt. M.Jayasree, Government Advocate who assisted the above Special Government Pleader (CS) in this case.
