Highways Department - Projects wing – Madurai circle – Madurai Division – Administrative and Financial Sanction – Land Acquisition for “Construction of ROB at Km 0/2-4 of Thirumangalam Municipality road in lieu of existing LC No. 377 at Railway km 512/400-500 in between Thirumangalam and Kallikudi Railway Stations”, for an amount of Rs.17.10 Crores – Orders – Issued.

ORDER:

In the Government Order first read above, orders were issued according administrative sanction for an amount of Rs.39.01 Lakhs for preparation of Detailed Project Report for “Construction of ROB at Km 0/2-4 of Thirumangalam Municipality road in lieu of existing LC No. 377 at Railway km 512/400-500 in between Thirumangalam and Kallikudi Railway Stations”

2) The Chief Engineer (H), Projects in his letter second read above has stated that Thirumangalam is one of the thickly populated municipal town in Madurai District and is busy throughout the day and night. The Railway Level Crossing No. 377 is situated at Km 0/2-4 of Thirumangalam-Municipality road. The people from Thirumangalam often cross the above level crossing for their way to Vidathakukam, Virusankulam, Alangalum and many other villages. The vehicles crossing over this LC are constantly getting hampered owing to frequent gate closures. As this is a densely populated area, the residents and students find very difficult to reach the nearby market, Hospital, Bus stand, Temples and Educational institutions. All agricultural produces from nearby villages are being carried through this level crossing to reach the marketing centres. This road also connects the Madurai Airport. Based on above circumstances, the Construction of ROB at this Railway level crossing is very much essential to promote free flow of traffic in Thirumangalam.

3) The Chief Engineer (H), Projects has further stated that the alignment of the proposed Road Over Bridge was approved by the alignment committee on 19.01.2017 and the field particulars for the above work was submitted to

Chief Engineer (H), Planning, Designs and Investigation Wing for preparation of detailed estimate and drawings and the land acquisition for the ROB alignment falls on Thirumangalam - Ward E & Ward C. The total extent of land required for the construction of above ROB work is 10,677.30 Sq. m which involves Private lands, HR & CE Lands and Other Government Department Lands and the Land Plan Schedule was submitted to DRO, Madurai on 27.05.2020. Necessary compensation for acquiring lands, structures, trees, any other assets attached have to be paid for project affected person as per latest prevailing Land Acquisition rules and acts. Accordingly, the land acquisition estimate has been prepared for an amount of Rs.17.10 Crores for payment towards compensation as per latest rules in force.

4) The Chief Engineer (H), Projects has therefore requested the orders of the Government to accord Administrative Sanction for Land Acquisition for "Construction of ROB at Km 0/2-4 of Thirumangalam Municipality road in lieu of existing LC No. 377 at Railway km 512/400-500 in between Thirumangalam and Kallikudi Railway Stations" for an amount of Rs.17.10 Crores (Rupees Seventeen Crores Ten Lakhs Only).

5) The Government after careful examination, accept the proposal of the Chief Engineer (Projects), and accord Administrative and Financial Sanction for Land Acquisition for "Construction of Road Over Bridge at Km 0/2-4 of Thirumangalam Municipality road in lieu of existing LC No. 377 at Railway km 512/400-500 in between Thirumangalam and Kallikudi Railway Stations" for an amount of Rs.17.10 Crores pending clearance of NOC from Commissioner, Hindu Religious and Charitable Endowments involved in Land Acquisition.

6) The amount sanctioned in para 5 above shall be debited under the following head of account:-

"5054 – Capital Outlay on Roads and Bridges – 03 – State Highways – 101 – Bridges – State's Expenditure – JG – Construction of over and under bridges in lieu of Existing level crossings – 416 – Major Works" – 01.Major Works.

7) The Chief Engineer (Projects), Highways Department is authorized to incur the expenditure sanctioned in para 5 above.

8) The expenditure sanctioned in Para 5 above shall constitute an item of "New Instrument of Service" and approval of the Legislature will be obtained in due course. Pending approval of the Legislature, the expenditure will be initially met by an advance from the Contingency Fund. The Chief Engineer (Projects), Highways Department is directed to calculate the actual amount required for the period upto next supplementary estimates and apply for sanction of the same as advance from the Contingency Fund to Finance (B.G-I) Department directly in Form 'A' appended to the Tamil Nadu Contingency Fund Rules, 1963 along with a copy of this order. Orders for sanction of an advance from the Contingency Fund will be issued from Finance (B.G-I) Department. The Chief Engineer (Projects), Highways Department is also directed to send a draft explanatory notes for inclusion the above expenditure in the Supplementary Estimates 2020-2021 to Finance (BG-I)/PW-I Department without fail.

9. This order issues with the concurrence of Finance Department vide its U.O. No.31/D.S.(S.A)/PW-I/2021, dated 05.02.2021 and Additional Sanction Ledger No.1652 (One thousand six hundred and fifty two).
