ORDER:

In the Government Order first read above, orders were issued according Administrative Sanction for an amount of Rs.10,50,00,000/- for the work of "Widening from Two Lane to Four Lane and improvements to Korathalaiyar Bridge-Puthur Road (SH-51) Km 18/0-21/0 including Land Acquisition" under Comprehensive Road Infrastructure Development Programme (CRIDP) Scheme for 2010-2011.

- 2. In the Government Order second read above, orders were issued constituting a committee consisting of Commissioner of Land Administration (Convener), Finance Secretary or his Nominee (Member), Secretary of the concerned Administrative Department (Member), Head of Department/ nominee of the requisitioning Department/ Agency and Representative of Legal Affairs Secretary (Member) for approval and recommendation of Revised Administrative Sanction proposals only for Land Acquisition.
- 3. Based on the Government order second read above, the Chief Engineer (H), Construction and Maintenance has placed the proposal of Revised Administrative Sanction for Land Acquisition cost for the work of "Widening from Two Lane to Four Lane and improvements to Korathalaiyar Bridge-Puthur Road (SH-51) Km 18/0-21/0 for total extent of land to be acquired (40968 Sq.mts.) for approval/recommendation, for the large increase in the cost of Land Acquisition due to revision of compensation in compliance with RFCTARR Act, 2013, RFCTLARR (Tamil Nadu Amendment) Act, 2014, TN RFCTLARR Rules, 2017 as originally the Land Acquisition cost was included as lumpsum provision.

- 4. The Revised Administrative Sanction committee has recommended the S above proposal to Government to accord the Revised Administrative Sanction for Land Acquisition.
- 5. Based on the recommendation of the Revised Administrative Sanction committee, the Government, after careful examination, hereby accord Revised Administrative Sanction for Land Acquisition cost for the work of Widening from Two Lane to Four Lane and improvements to Korathalaiyar Bridge-Puthur Road (SH-51) Km 18/0-21/0" for an amount of Rs.9,78,89,409/- as against the original provision of Rs.88,05,556/-.
- 6. The expenditure sanctioned in Para-5 above, shall be met from the existing budget provision under following head of account:-

"5054 – Capital Outlay on Roads and Bridges-03-State Highways – 337-Road works State's Expenditure - JI - Comprehensive Road Infrastructure Development Programme (CRIDP) - State Highways - 416- Major Works 01- Major Works."

- 7. The Chief Engineer (H), Construction and Maintenance is authorized to incur the expenditure sanctioned in para 5 above.
