The Governor of Tamil Nadu having been satisfied that the lands specified in the Schedule below are required for Highways purpose to wit for upgrading State Highways Road (SH-15) - Gobichettypalayam - Erode Road in **Pallapalayam, Nallagoundanpalayam and Chithode Villages, Perundurai and Erode Taluks in Erode District** and it having already been decided that the entire amount of compensation to be awarded for the lands is to be paid out of the funds controlled and managed by Divisional Engineer (Highways) Tamil Nadu Road Sector Project-II, Tiruppur and after having considered the cause shown by the owner or other persons having interest on such lands as the case may be, do hereby publish the following notice under sub-section (1) of Section 15 of the Tamil Nadu Highways Act, 2001 (Tamil Nadu Act, 34 of 2002)

Under sub-section (1) of Section 15 of the Tamil Nadu Highways Act, 2001 (Tamil Nadu Act 34 of 2002), the Governor of Tamil Nadu hereby acquires the Rayatwari dry lands specified in the Schedule below and measuring to an extent of 1962 Square Metres for the purpose of upgrading the State Highways Road, (SH-15) Gobichettypalayam - Erode Road from KM 123/000 to KM 153/600 in **Pallapalayam, Nallagoundanpalayam and Chithode Villages, Perundurai and Erode Taluks in Erode District.**
