### ORDER:-

In the Government order first read above, orders were issued constituting a Committee consisting of representatives of Finance Department, Highways and Minor Ports Department, Director General and concerned Chief Engineers of Highways Department for scrutiny of Revised Administrative Sanction proposals.

2) In the Government order second read above, orders were issued according administrative sanction for Rs.410.07 lakhs to acquire land to an extent of 407245 sq.mtr for a length of 13.675 Km and width 30.00 mtr and for preparation of Detailed Project report for the formation of bypass road to Rasipuram Town in Namakkal District.

3) In the Government order third read above, orders were issued according first Revised Administrative Sanction for Rs.711.79 lakhs and in the Government order fourth read above, orders were issued according second Revised

Administrative Sanction for Rs.928.11 lakhs. Further in the Government order fifth read above, orders were issued according third RAS for Rs.1657.00 lakhs.

4) The Chief Engineer (Construction and Maintenance) Highways Department in her letter sixth read above, has stated that out of seven villages, possession had been handed over to highways department in respect of five villages (Kalyani, Pilanalur, Ponkuruchi, Ayeepalayam, Krukkapuram) for which 100% solatium has to be disbursed as per RFCTLARR Act 2013. For Anaipalyam Village, valuation proposal had been sent to CLA and for Kumarapalyam village, award proposal is under preparation. The District Revenue Officer, Namakkal has stated that based on the judgement dated 18.4.2018 of the Hon'ble High Court of Madras in W.P.No.9526/2016 filed by the land owners, Thiru.Palanivel and others, compensation for the land acquisition has to be disbursed as per RFCTLARR Act 2013 and accordingly compensation was worked out to a net increase in amount of Rs.2000 lakhs. Hence, incorporating the above provisions, the total cost for "Land Acquisition for forming Rasipuram Bypass road from Km 2/8-13/675 works out to Rs.3657.00 lakhs for acquisition of land extent of 281956 sqm. Hence, the Chief Engineer (Construction and Maintenance) has requested 4<sup>th</sup> Revised Administrative sanction for an amount of Rs.3657.00 lakhs.

5) The above Committee on RAS in its meeting held on 27.08.2018 recommended the 4<sup>th</sup> Revised Administrative sanction relating to land acquisition for formation of Rasipuram bypass for an amount of Rs.3657.00 lakhs.

6) The Government after careful examination, accept the proposal of the Chief Engineer (Construction and Maintenance) Highways Department and accord 4<sup>th</sup> Revised Administrative Sanction amounting to Rs.3657.00 lakhs (Rupees Thirty Six crores and Fifty Seven Lakhs only) as recommended by the Revised Administrative Sanction Committee for land acquisition for formation of Rasipuram bypass from km 2/8-13/675 as against the Third Revised administrative sanction amount of Rs.1657 lakh, and financial sanction for Rs,20,00,00,000/- for the year 2018-19.

7) The expenditure sanctioned in para-6 above shall be debited to the following head of account:-

"5054 - Capital outlay on Roads and Bridges – 04 –  
District and other roads – 800 – Other Expenditure –  
State's Expenditure – JK – Acquisition of Lands for  
Bye Passes – 64 - Lands"

8) The expenditure sanctioned in Para-6 above is an item of "New Instrument of Service". The approval of the Legislature will be obtained in due course. Pending approval of Legislature, the expenditure may be initially met by drawal of an advance from the Contingency Fund. The Chief Engineer (Construction and Maintenance) Highways Department is directed to calculate the actual amount required for the period upto next supplementary estimates and apply for sanction of the same as advance from the Contingency Fund to Finance (B.G-I) Department directly in Form 'A' appended to the Tamil Nadu Contingency Fund Rules, 1963 along with a copy of this order. Orders for sanction of an advance from the Contingency Fund will be issued from Finance (B.G-I) Department separately. He is also directed to send a

draft explanatory notes for inclusion the above expenditure in the Supplementary Estimates 2018-19 to Finance (BG-I/PW-I) Department without fail.
