ORDER:-

In the Government Order first read above, Government accorded administrative sanction under RIDF XXII for an amount of Rs.56.755 crores for the construction / Reconstruction of 24 Bridges which includes the work of "Construction of High Level Bridge at km 21/2 of Gudiyatham-Gadambur-Kailasagiri-Vaniyambadi Road" for an amount of Rs.697.00 lakhs.

- 2. In the letters second read above, the Chief Engineer (NABARD and Rural Roads), Highways Department has earlier sent the Revised Administrative Sanction proposal for an amount of Rs.1662.00 lakhs instead of originally sanctioned amount of Rs.697.00 lakhs due to change in foundation type from open to pile, change in schedule of rate from 2015-16 to till date with 4 years escalation and inclusion of provision of GST. Later he has requested for fresh Administrative Sanction for Rs.1662.00 lakhs under State Fund or any other scheme instead of Revised Administrative Sanction justifying the following points:-
 - The amount of Rs.1662.00 lakhs required for the above bridge work is nearly 2.40 times of originally sanctioned amount.
 - After a lapse of three years from the date of sanction of the above bridge work, only 2 more years are available (since one Tranche is available for 5 years) to complete this project as per the NABARD norms. But till date, this work is in estimate stage itself.
- 3. The Chief Engineer (NABARD and Rural Roads), Highways Department has therefore requested the Government to accord administrative sanction for the work of "Construction of High Level Bridge at km 21/2 Gudiyatham-Gadambur-Kailasagiri-

Vaniyambadi Road across Malataru river" for an amount of Rs.1848.00 lakhs under State Fund and to delete the work from the original sanctioned Government Order first read above.

- 4. The Government after careful examination, accept the proposal of the Chief Engineer (NABARD & Rural Roads), Highways Department and permit to delete the work of "Construction of High Level Bridge at km 21/2 Gudiyatham-Gadambur-Kailasagiri-Vaniyambadi Road across Malataru river" from the originally sanctioned Government order first read above and accord administrative sanction for an amount of Rs.16,93,00,000/- (Rupees Sixteen Crore and Ninty Three Lakhs only) for the above work under State fund.
- 5. The expenditure sanctioned in para 4 above shall be debited under the following new head of account:-

"5054 – Capital Outlay on Roads and Bridges – 04. District and Other Roads – 337. Road Works – State's Expenditure – KJ. Construction / Reconstruction of Bridges under State Fund – 416. Major Works – 01. Major Works."

- 6. The Chief Engineer (NABARD and Rural Roads) is the Estimating, Reconciling and Controlling authority for the above said new head of account.
- 7. The Chief Engineer (NABARD and Rural Roads) is authorized to draw and disburse the amount sanctioned in para 4 above from the Budget Provision of 2020-2021.
- 8. This order issues with the concurrence of Finance Department vide its U.O. No.3396/PW-I/2020, dated 04.02.2020.
