Highways Department - Metro Wing - execute on the Equal Value of Infrastructure (EVI) and creation / recreation of assets proposed to be demolished in the defence land for the work of "Construction of Grade Separator at the intersection of Sandhai Road and Kundrathur Road with GST Road at Pallavaram – accorded – orders – issued.

ORDER:

In the Government order first read above, Administrative Sanction was accorded for an amount of Rs.80.74 Crore for the work of "Construction of Grade separator at the intersection of Sandhai Road and Kundrathur Road with GST Road at Pallavaram with

- 2. In the Government order second read above, Revised Administrative Sanction was accorded for an amount of Rs.104.34 crore with revised nomenclature of construction of Grade separator at the intersection of Sandhai road and Kundrathur road with GST Road at Pallavaram.
- 3. In the letter third read above, the Chief Engineer (H), Metro has stated that the configuration of above Grade Separator is unidirectional three lane carriageway having 12m width for catering the straight traffic from Tambaram to Guindy on RHS. On LHS, the proposal is 3 lane carriage way with footpath at grade for the main traffic plying from Guindy to Tambaram. The existing available width is not sufficient for the at grade traffic. The Defence land is abutting the carriageway on LHS at that location. Only after acquiring that land, the widening of at grade road can be completed, Hence, the proposal was sent to the Estate Officer, Defence Teynampet, Chennai for requesting the transfer of Defence land.
- 4. The Chief Engineer (H), Metro has further stated that the District Collector, Chengalpattu has requested the Defence Estate Officer, Chennai Circle to accord

consent for transfer of 21440 sq.ft (0.4922 acres) time expired lease land in Pallavaram in lieu of Defence land. Further, the Defence Estate Officer, Madras circle, Chennai has requested to accord working permission for transfer of Defence land measuring 0.5349 acres from the Principal Director, Defence Estates (Lands Sec.), Ministry of Defence, Southern Command, Pune Cantonment.

- 5. The Ministry of Defence, Government of India, New Delhi has granted working permission to State Highways Department of Tamil Nadu on Defence land measuring 0.5349 acres comprising GLR Sy.Nos.388/707, 388/707A, 388/708, 388/246-6A and 388/14 (part) at St. Thomas Mount cum Pallavaram Cantonment based on the Equal Value of Infrastructure (EVI) and creation / recreation of assets proposed to be demolished for an amount of Rs.15,76,50,809.52/- and the same has been included in the Draft MOU approved by the Government. The above extent is under the control of three managements, viz.,
 - i) Defence Estate Officer, Army,
 - ii) Air force
 - iii) Cantonment Board
- 6. The Chief Engineer (H), Metro has, therefore requested the Government to sanction a sum of Rs.15,76,50,809.52/- to execute the work based on the Equal Value of Infrastructure (EVI) and creation / recreation of assets proposed to be demolished in the defence land for the work of "Construction of Grade Separator at the intersection of Sandhai Road and Kundrathur Road with GST Road at Pallavaram" and also requested necessary permission to deposit the remaining amount to Consolidated Fund of India (CFI), if the cost of infrastructure being constructed is less than cost of said defence land.
- 7. The Government after careful examination, have decided to accept the proposal of the Chief Engineer (H), Metro and accord sanction for a sum of Rs.15,76,50,809/- (Rupees Fifteen Crore Seventy Six Lakh Fifty Thousand Eight Hundred and Nine only) to execute the work based on the Equal Value of Infrastructure (EVI) and creation / recreation of assets proposed to be demolished in the defence land for the work of "Construction of Grade Separator at the intersection of Sandhai Road and Kundrathur Road with GST Road at Pallavaram". The Chief Engineer (H), Metro is also granted necessary permission to deposit the remaining amount to Consolidated Fund of India (CFI), if the cost of infrastructure being constructed is less than cost of said defence land. Government also accord Financial Sanction for a sum of Rs.7,00,00,000/- (Rupees Seven Crore Only) for the current financial year 2023-2024 and the balance amount will be released in the subsequent financial year based on requirements.
- 8. The expenditure sanctioned in para-7 above shall be debited to the following head of account:

"5054 – Capital outlay on Roads and Bridges – 80 - General – 800 – Other expenditure State's expenditure - JW – Chennai Metropolitan Development Plan – Traffic and Transport Improvement in Chennai City – 416 – Major Works – 01 – Major works."

- 9. The expenditure sanctioned in Para 7 above shall constitute an item of "New Instrument of Service" and approval of the Legislature will be obtained in due course. Pending approval of the Legislature, the expenditure will be initially met by an advance from the Contingency Fund. The Chief Engineer (Metro), Highways Department is directed to calculate the actual amount required for the period upto next Supplementary Estimates and apply for sanction of the same as advance from the Contingency Fund to Finance (B.G-I) Department directly in Form 'A' appended to the Tamil Nadu Contingency Fund Rules, 1963 along with a copy of this order. Orders for sanction of an advance from the Contingency Fund will be issued from Finance (B.G-I) Department. The Chief Engineer (Metro), Highways Department is also directed to send a draft explanatory notes for inclusion the above expenditure in the Supplementary Estimates 2023-2024 to Finance (BG-I/PW-I) Department without fail.
- 10. This order issues with the concurrence of the Finance Department vide its U.O.No.10018/PW-I/2023 dated: 11.04.2023 and Additional Sanction Ledger No.0006 (Six) (IFHRMS ASL NO.2023040006).
