ORDER:

During the Budget Demand for 2017-18 for the Highways Department held on 28-06-2017, the Hon'ble Chief Minister has made 15 announcements in the floor of Assembly for developing the Highways Infrastructure and providing a better connectivity. **Announcement No.8** pertains to carryout the Land Acquisition for providing Alternate Route from Pollachi to Coimbatore (via) Chettipalayam for an amount of Rs. 4.00 Crore.

2. Based on the above announcement, the Chief Engineer (Highways) Projects in his letters read above has stated that at present, the entire traffic from Pollachi to Coimbatore and vice-versa passes through NH-83. By providing this alternate route from Pollachi to Coimbatore (via) Chettipalayam will act as a bypass for NH-83 and thus reduces the traffic congestion on NH-83 and which leads to the best connectivity for the villages of Chettipalayam, Myleripalayam, Arasampalayam, Kondampatty, Kothavadi, Kondangipalayam, Nallattipalayam, Mullupadi, Kaniyalampalayam and Mettupalayam.

3.The Chief Engineer (H), Projects has further stated that the cost of land acquisition including the preparation of Detailed Project Report works out to Rs.4.10 Crores for a length of 23.7kms. The total extent of land to be acquired in 10

villages is 54450 sqm. The cost of Land acquisition for this work is taken up based on the present guideline value which includes the Detailed Project Report charges.

4. The Chief Engineer (Highways), Projects has therefore requested the Government to accord Administrative Sanction to the tune of **Rs.4.10 Crores** for carrying out the Detailed Project Report and Land Acquisition for the work of **“Widening to Double Lane from km 19/10 of Coimbatore Nagapattinam road (NH 83) to km 31/2 of Palladam – Cochin Frontier road (SH 163) (via) Mullupadi, Myleripalayam and Chettipalayam (Alternate route from Pollachi to Coimbatore).**

5. The Government after careful examination, accept the proposal of the Chief Engineer (Highways) Projects and accord Administrative Sanction for an amount of **Rs.4.10 Crores** (Rupees Four Crore and Ten Lakhs Only) (ie) at the cost of Rs.20 lakhs for preparation of Detailed Project Report and at the cost of Rs.390.00 lakhs for land acquisition for the work of **“Widening to Double Lane from km 19/10 of Coimbatore-Nagapattinam road (NH 83) to km 31/2 of Palladam – Cochin Frontier road (SH 163) (via) Mullupadi, Myleripalayam and Chettipalayam (Alternate route from Pollachi to Coimbatore).**

6. The expenditure sanctioned in para-5 above shall be debited to the following Head of Account:-

Preparation of Detailed Project Report-Rs.20.00 lakhs

5054 – Capital Outlay on Roads and Bridges – 80 – General – 004 – Research and Development – State’s Expenditure-AA- Investigation/Estimation of Project work under Roads and Bridges – 16 Major works.

(D.P.Code 5054-80-004 AA 1609)

Land Acquisition-Rs.390.00 lakhs

5054-Capital Outlay on Roads and Bridges – 80 – General 800 – Other Expenditure – State’s Expenditure JN-Provision for Road works 64 Lands.

7. The expenditure for Rs.20.00 lakhs sanctioned in para above for preparation of Detailed Project Report shall be incurred from the existing provision of BE 2017-18. The expenditure for Rs.390.00 lakhs sanctioned for land acquisition shall constitute an item of “New Instrument of Service” and the approval of the legislature shall be obtained in due course of time by an inclusion in the Supplementary Estimates for the year 2017-18. Pending approval of the Legislature, the expenditure shall initially be met by an advance from the Contingency Fund. The Chief Engineer (Projects), Highways is directed to calculate the actual amount required for the period upto next Supplementary Estimates and apply for sanction of the same as advance from the Contingency Fund to Finance (BG-I) Department directly in Form “A” appended to the Tamil Nadu Contingency Fund

Rules 1963 along with a copy of this Order. Orders regarding this will be issued by the Finance (BG.I) Department separately. The Chief Engineer (Projects), Highways is directed to send necessary explanatory notes for inclusion of the above expenditure in the Supplementary Estimates for the year 2017-18 to Finance (BG-I/PW-I) Department at the appropriate time without fail.

8. This order issues with the concurrence of Finance Department vide its U.O. No.65786/PW-I/2017, dated 06-01-2018 and Additional Sanction Ledger No.2420 (Two Thousand Four Hundred and Twenty.)
