ORDER:

In the Government order first read above, orders were issued for constituting a Committee consisting of representatives of Finance Department, Highways and Minor Ports Department, Director General and Concerned Chief Engineers' of Highways Department for scrutiny and review of the Revised Administrative Sanction proposals.

- 2. In the Government order second read above, Administrative Sanction was accorded for a sum of Rs.36.00 Crore for the work of formation of Bypass to Tiruttani town starting from Km 10/4 of NH 205 and ending at Km 104/2 of Sadras Chengalpattu Kanchipuram Arakkonam Tiruttani Road (SCKAT Road SH58) including construction of a bridge across Nandhi river and Railway Over Bridge at Km 2/3 2/8 between Tiruttani and Arakkonam Stations.
- 3. In the Government Order third read above, Revised Administrative Sanction-I was accorded for a sum of Rs.46.06 Crore (Rupees Forty Six Crore and Six lakh only) for the work of "formation of Bypass to Tiruttani town starting from Km 10/4 of NH 205 and ending at km 104/2 of Sadras Chengalpattu Kanchipuram Arakkonam Tiruttani Road (SCKAT Road SH58), including construction at a bridge across Nandhi river and Railway Over Bridge at Km 2/3 2/8 between Tiruttani and Arakkonam Stations".

- 4. In the letter fourth read above, the Chief Engineer(H), has stated that, Tiruttani Bypass road work is nearing completion i.e. 94% of the work is completed, only railway portion has to be executed by Railway department which is in progress. The two adjacent deck slab can be carried out only after the completion of the railway portion. As per the Railway department's demand, an amount of Rs.6,17,47,062/- has been remitted on 19.11.2019 for the construction of ROB in railway portions. At this juncture, the Railway department has sent a revised demand vide, letter Dated 04.04.2022 to a total amount of Rs.11,06,68,313/- for the construction of railway portion which is in excess of Rs.4,89,21,251/- of demand already been received, due to the change in the design in Railway portion.
- 5. The Chief Engineer, Construction and Maintenance has also stated that the actual price escalation payment made as on date works out to Rs.2,20,69,269/- which is in excess of Rs.66,94,942/- above the escalation charges provision made in the revised estimate-I. As per the demand of the Railway Department and the actual price escalation paid and other probable costs, revised estimate-II works out to Rs.52.00 Crore which is Rs.5.94 Crore more than the Revised Administrative Sanction-I amount of Rs.46.06 Crore and it is detailed in the table given below.

- 6. The Chief Engineer, Construction and Maintenance has further stated that these proposed were are in costs are essential. Hence, the Revised Administrative Sanction-II proposal for the above mentioned work for an amount of Rs.52.00 Crore was placed before the Revised Administrative Committee. The committee, during the meeting held on 09.12.2022, has approved the proposal and recommended for according Revised Administrative Sanction-II.
- 7. The Chief Engineer, Construction and Maintenance has requested the Government to accord Revised Administrative Sanction-II for an amount of Rs.52.00 Crore for the work of "Formation of By Pass Road to Tiruttani Town starting from Km 10/4 of NH 205 and ending at Km 104/2 of Sadras Chengalpattu Kanchipuram Arakkonam Tiruttani Road (SCKAT Road- SH.58) including Construction of a Bridge Across Nandhi River and Railway Over Bridge at Km 2/3 2/8 Between Tiruttani and Arakkonam Stations".
- 8. The Government, after careful examination, accept the proposal of the Chief Engineer (H), Construction and Maintenance and accord Revised Administrative Sanction-II for an amount of Rs.52.00 Crore for the work of "Formation of By Pass Road to Tiruttani Town Starting from Km 10/4 of NH 205 and ending at Km 104/2 of

Sadras - Chengalpattu - Kanchipuram - Arakkonam - Tiruttani Road (SCKAT Road-SH.58) including Construction of a Bridge across Nandhi River and Railway Over Bridge at Km 2/3 - 2/8 Between Tiruttani and Arakkonam Stations" as Revised Administrative Sanction-I amount of Rs.46.06 Crore.

9. The expenditure sanctioned in para-8, above shall be met from the existing budget provision under the following Head of account:

5054-Capital Outlay on Roads and Bridges - 03 State Highways - 337 Road Works - State's Expenditure - JI - Comprehensive Road Infrastructure Development Programme (CRIDP) - State Highways - 416 Major Works - 01.Major Works.
