ORDER:-

In the Government Order first read above, orders were issued constituting a Committee consisting of representatives of Finance Department, Highways and Minor Ports Department, Director General and concerned Chief Engineers of Highways Department for scrutiny of Revised Administrative Sanction and Review of the Revised Administrative Sanction proposals.

2) In the Government Order second read above, Administrative Sanction was accorded for Land Acquisition for the work of "Forming Bypass to Namakkal Town Km.0/0-22/387 including Link Road to a length of 200m branching at Km.0/8 of Namakkal Bypass to proposed Namakkal Bus stand" for an amount of Rs.1070.20 Lakhs.

3) In the Government Order third read above, 1st Revised Administrative Sanction was accorded for Land Acquisition for the work of "Forming Bypass to Namakkal Town Km.0/0-22/387 including Link Road to a length of 200m branching at Km.0/8 of Namakkal Bypass to proposed Namakkal Bus stand" for an amount of Rs.2494.61 Lakhs.

4) The Committee on Revised Administrative Sanction in its meeting held on 30.01.2019 has approved the following proposal of Chief Engineer (NABARD and Rural Roads) Highways Department :-

5) The Chief Engineer (NABARD and Rural Roads) Highways Department has therefore requested the Government to approve IInd Revised Administrative Sanction for Land Acquisition for the work of "Forming Bypass to Namakkal Town Km.0/0-22/387 including Link Road to a length of 200m branching at Km.0/8 of Namakkal Bypass to proposed Namakkal Bus stand" for an amount of Rs.8700.00 Lakhs as recommended by Revised Administrative Sanction Committee.

6) The Government after careful examination, accept the proposal of the Chief Engineer (NABARD and Rural Roads), Highways Department and accord IInd Revised Administrative Sanction for Land Acquisition for the work of "Forming Bypass to Namakkal Town Km.0/0-22/387 including Link Road to a length of 200m branching at Km.0/8 of Namakkal Bypass to the proposed Namakkal Bus stand" for an amount of Rs.87,00,00,000/- (Rupees Eighty Seven Crore only) as recommended by the Revised Administrative Sanction Committee as against the

1st Revised Administrative Sanction an amount of Rs.24,94,61,000/- (Rupees Twenty Four Crore Ninety Four Lakh and Sixty One Thousand only).

7) The expenditure sanctioned in para-6 above shall be debited to the following head of account:-

8) The expenditure sanctioned in Para 6 above is an item of "New Instrument of Service". The approval of the Legislature shall be obtained in due course. Pending approval of the Legislature, the expenditure may be initially met by drawal of an advance from the Contingency Fund. The Chief Engineer (NABARD and Rural Roads) Highways Department, Chennai is directed to calculate the actual amount required for the period up to next Supplementary Estimates and apply for sanction of the same as advance from the Contingency Fund to Finance (BG-I) Department directly in Form "A" appended to the Tamil Nadu Contingency Fund Rules 1963 along with a copy of this order. Orders for sanction of an advance from the Contingency Fund will issued from Finance (BG-I) Department separately. He is also directed to send a draft explanatory notes for inclusion of the above expenditure in the Supplementary Estimates/Revised Estimate 2019-20 to Finance (BG-I)/(PW-I) Department without fail.

9) This order issues with the concurrence of Finance Department vide its U.O.No.20982/PW-I/2019 dated 28.05.2019 and Additional Sanction Ledger No.344 (Three Hundred and Forty four).
