**NOTIFICATION**

The Governor of Tamil Nadu having been satisfied that the lands specified in the Schedule below are required for Highways purpose to wit for four laning and strengthening of Oddanchatram – Dharapuram – Tiruppur Road (SH-37) from Km 37/400 to Km 126/200 in **Thangachiyammappatti, Ambilikai, Mandavadi, Kariyampatti, and Poosaripatti Villages, Ottanchatram Taluk in Dindigul District** and it having already been decided that the entire amount of compensation to be awarded for the lands is to be paid out of the funds controlled and managed by Divisional Engineer (Highways) Tamil Nadu Road Sector Project-II, Salem and after having considered the cause shown by the owner or other persons having interest on such lands as the case may be, do hereby publish the following notice under sub -section (1) of Section 15 of the Tamil Nadu Highways Act, 2001. Under sub-section (1) of Section 15 of the Tamil Nadu Highways Act, 2001 (Tamil Nadu Act 34 of 2002), the Governor of Tamil Nadu hereby acquires the dry lands specified in the Schedule below and measuring to an extent of 2433 Square Metres for the purpose of four laning and strengthening of Oddanchatram – Dharapuram – Tiruppur Road (SH-37) from Km 37/400 to Km 126/200 in **Thangachiyammappatti, Ambilikai, Mandavadi, Kariyampatti, and Poosaripatti Villages, Ottanchatram Taluk in Dindigul District.**
