NOTIFICATION

The Governor of Tamil Nadu having been satisfied that the lands specified in the Schedule below have to be acquired for Highways purpose for the forming Road Over Bridge in Salem District, Omalur Taluk, T.Maramangalam Village at Km 7/2 of Tholasampatty (ODR) road in lieu of existing LC.No.15 at Railway Km 15/800-900 in between Omalur and Mechery railway station and it has already been decided that the entire amount of compensation to be awarded for the lands is to be paid out of the funds controlled or managed by the Divisional Engineer (Projects), Highways Department, Salem District after considering the cause shown by the owner (or) other person having interest on such lands as the case may be do hereby publish the following notice under sub-section (1) of Section 15 of the Tamil Nadu Highways Act, 2001 (Tamil Nadu Act 34 of 2002).

Under Sub-Section (1) of Section 15 of the Tamil Nadu Highways Act, 2001 (Tamil Nadu Act 34 of 2002) the Governor of Tamil Nadu hereby acquires the land specified in the Schedule below measuring to an extent of 1368.0 sq.mtrs of dry lands in Salem District, Omalur Taluk to the same, a little more or less needed for the forming Road Over Bridge in Salem District, Salem.
