



ABSTRACT

Highways Department – Projects Wing – Coimbatore (H) Projects Circle – Salem (H) Projects Division – Formation of Bypass to Rasipuram Town Phase-II starting from Km 30/6 of Malliyakkarai – Rasipuram – Tiruchengode – Erode road (State Highways-79) and ends at Km 52/4 of Mohanur – Namakkal – Sendamangalam – Rasipuram road (State Highways-95) - Administrative Sanction for Land Acquisition - Accorded - Orders - Issued.

ORDER:-

In the Government order first read above, the Government have accorded Administrative Sanction for a sum of Rs.38,97,000/- for the preparation of Detailed Project Report for Forming By-pass to Rasipuram Town Phase-II starting from km 30/6 of Malliyakkarai – Rasipuram – Tiruchengode – Erode road (State Highways-79) and ends at km 52/4 of Mohanur – Namakkal – Sendamangalam - Rasipuram road (State Highways-95).

2. In the letter second read above, the Chief Engineer (Projects), Highways Department has stated that, the proposed Bypass is located at Rasipuram municipality in Namakkal district at a distance of 31 km from Namakkal city. Rasipuram is well connected by important State Highways roads and it is congested with traffic from State Highways-95 and National Highways-7. All the vehicules plying in State Highways-95 have to cross Rasipuram town. The existing road is very narrow and also congested and no space on either side of the above said road for further widening. Similarly, in State Highways-79 Namagiripettai junction and the Seerapalli junctions are very narrow and are in builtup area. During the peak hours, traffic jam occurs frequently due to the heavy vehicular traffic. Many educational institutions have been established nearby the town and operating more than 200 buses during peak hours. After completion of Rasipuram Bypass phase-II, the traffic from Athur, Kallakurichi, Namakkal, Tiruchengode and Erode will pass through this bypass and the traffic congestion in

Namagiripettai and Seerapalli town Panchayat built up area will be avoided. The alignment of the proposed Bypass has been approved by the alignment committee on 25.03.2014. The proposed alignment branches at Thanneerpandalkadu in Km 30/6 of Malliyakkarai - Rasipuram - Tiruchengode - Erode road (State Highways-79) and joining at Km 52/4 of Mohanur - Namakkal - Sendamangalam - Rasipuram road (State Highways-95). The total length of this Bye pass road is about 11.20 Km.

3. The Chief Engineer (Projects), Highways Department has also stated that, the Land acquisition is prepared to acquire a width of 30m for new formation. The total length of Alignment is 11120 m. For this, the Land to be acquired in eight villages namely Namagiripettai (3885.33 sqm), Ariyagoundampatty (91261.89 sqm), O.Pachudayampalayam (24896.02 sqm), O.Jedarpalayam (6444.93 sqm), Tho.Jedarpalayam (22848.74 sqm), Thoppapatti (75610.62 sqm), Singalanthapuram (59418.34 sqm), Kakkaveri (23416.42 sqm) and the total land acquisition area is 307782.29 sqm and the Land Alienation area is 28994 sqm. Ten villages namely Thanneerpanthalkadu, Pachudayampalayam, Thoppampatty, Jedarpalayam, Annamarkovil, Kumanannaickanur, Bodinaickenpatty & Appanaickenpatty are benefited by this proposal. Necessary compensation for acquiring lands, structures, trees any other assets attached have to be paid for project affected owners as per latest prevailing land acquisition rules and acts. Accordingly the Land Acquisition estimate has now been prepared to an amount of Rs.29.10 Crores for an area of 307782.29 sqm for payment of compensation as per latest rules in force.

4. The Chief Engineer (Projects), Highways Department has therefore requested the Government to accord Administrative Sanction for carrying out Land Acquisition for the work of "Formation of Bypass to Rasipuram Town Phase-II starting from km 30/6 of Malliyakkarai - Rasipuram - Tiruchengode - Erode road (State Highways-79) and ends at km 52/4 of Mohanur - Namakkal - Sendamangalam - Rasipuram road (State Highways-95)" for a sum of Rs.29.10 Crore.

5. The Government after careful examination, accept the proposal of the Chief Engineer (Projects), Highways Department and accord administrative sanction for Land Acquisition for an amount of Rs.29,10,00,000/- (Rupees Twenty Nine Crore and Ten Lakh Only) for the work of "Formation of Bypass to Rasipuram Town Phase-II starting from Km 30/6 of Malliyakkarai - Rasipuram - Thiruchengode - Erode road (State Highways-79) and ending at Km 52/4 of Mohanur - Namakkal - Senthamangalam - Rasipuram road (State Highways-95)".

6. The expenditure sanctioned in para-5 above shall be debited under the following head of account:-

"5054 - Capital Outlay on Roads and Bridges - 03 State Highways - 337 Road works - State's Expenditure - JO Comprehensive Road Infrastructure Development Programme (CRIDP) - Formation of Bye-passes - 464 Lands - 01 Lands - Voted."

7. The expenditure sanctioned in Para-5 above shall constitute an item of "New Instrument of Service" and approval of the Legislature will be obtained in due course. The Chief Engineer (Projects), Highways Department is also directed to send a draft explanatory notes for inclusion the above expenditure in the Supplementary Estimates 2020-2021 to Finance (BG-I/PW-I) Department without fail.

8. The Chief Engineer (Projects), Highways Department is authorized to incur the expenditure sanctioned in para 5 above.

9. This order issues with the concurrence of the Finance Department vide its U.O. No.9059/PW-I/2021, dated 21.02.2021 and Additional Sanctioned Ledger No.1917 (One Thousand Nine Hundred Seventeen)
