ORDER:

During the Collectors' Conference 2012-2013, the Hon'ble Chief Minister has made an announcement that "two flyovers one each at Kalavasal and Goripalayam in Madurai" will be sanctioned.

2. In the Government Order first read above orders have been issued sanctioning an amount of Rs. 65.00 lakhs for the preparation of Detailed Project Report for the construction of 2 flyovers one each at Kalavasal Junction and Goripalayam Junction in Madurai town.

3. Based on the above announcement, the Chief Engineer (Construction and Maintenance), Highways Department in his letter second read above has stated that, the construction of flyover at this intersection involves acquisition of land and buildings and the total extent of land to be acquired has been assessed as 11315 sq.m. and the compensation for the affected buildings located in the vicinity of the proposed structure is also included.

4. The Chief Engineer (Construction and Maintenance), Highways Department, has therefore requested the Government to accord administrative sanction for the acquisition of land for the construction of flyover at Goripalayam junction in Madurai town at a cost of Rs.164.30 crore.

5. The Government after careful examination, decided to accept the proposal of the Chief Engineer (Construction and Maintenance), Highways Department to accord administrative sanction for a sum of Rs.164.28 crore (Rupees One Hundred and Sixty Four Crore and Twenty Eight Lakhs only) for the acquisition of land for the construction of flyover at Goripalayam junction in Madurai town.

6. The expenditure sanctioned in para-5 above shall be debited to the following Head of Account:-

"5054-Capital Outlay on Roads and Bridges-04-District and other Roads-337-Road Works-Schemes in the Twelfth Five Year Plan-II-State Plan-KC-Acquisition of Lands for bye passes"- 64 Lands.

7. The expenditure sanctioned in para 5 above is an item of "New Service". The approval of the Legislature will be obtained in due course. Pending approval of the Legislature, the expenditure may be initially met by drawal of an advance from the Contingency Fund. The Chief Engineer (Construction and Maintenance), Highways Department, Chennai is directed to calculate the actual amount required for the period upto next supplementary estimates and apply for sanction of the same as advance from the Contingency Fund to Finance (B.G.I) Department directly in Form 'A' appended to the Tamil Nadu Contingency Fund Rules, 1963 along with a copy of this order. Orders for sanction of an advance from the Contingency Fund will be issued from Finance (B.G.I) Department. He is also requested to send a draft explanatory notes for including the above expenditure in the Revised Budget Estimate 2016-2017/Supplementary Estimate 2016-2017 to Finance (BG-I) Department without fail.
