ORDER:

The Hon'ble Chief Minister has made the following announcement for the year 2020-2021.

"During the year 2020-2021 an amount of Rs.200 Crore under the Comprehensive Road Infrastructure Development Program and an amount of Rs.150 Crore under the Road Safety Scheme works and Construction of Center medians in Madurai Corporation limit at a cost of Rs.50 Crore, to a total cost of Rs.400 Crore works were taken up specifically for the Road Safety".

- 2. The Chief Engineer (H), Construction and Maintenance has stated that all the Divisional Engineers were requested to prepare the proposals including the rectification of identified black spots, Fatal Road accidents occurred locations, Providing Metal crash barriers in the accident zones and providing Speed breakers in Government Roads covering Road safety aspects emphasizing the road safety on 4E's Viz., Education, Engineering, Enforcement, Emergency care in the following category.
 - a) Widening/Reconstruction of Narrow Culvert/Minor Bridge/Causeways
 - b) Realignment of 'S' curve/Acute curve
 - c) Construction of Safety wall/ Metal Crash barrier along High embankment / Hill road
 - d) Junction Improvements and improvement of accident prone spots
 - e) Providing of Speed breakers Highways roads.

3. The Chief Engineer (H), Construction and Maintenance has also stated that the consolidated proposal for all divisions in the above category arrives to a tune of **Rs.150.00 Crore** of these, the following categories are finalized as given below.

- 4. The Chief Engineer has therefore requested the Government,
 - (i) for administrative sanction for an amount Rs.150.00 Crore for carrying out works under the Road safety component.
 - (ii) to initiate land acquisition process even for works which do not specifically mention land acquisition in the nomenclature of work.
 - (iii) to permit the Chief Engineer (H), Construction and Maintenance to change the nomenclature works and delete works if need arises if no additional financial commitment is involved due to the same.
- 5. The Government after careful examination accept the proposal of the Chief Engineer (H), Construction and Maintenance and accord administrative sanction for a sum of Rs.150,00,00,000/- (Rupees One Hundred Fifty Crore only) for carrying out the work for all division for 1502 numbers of works under the Road Safety Component as detailed in the annexure to this order.
- 6. The expenditure sanctioned in para 5 above shall be debited to the following head of account:-

5054 - Capital Outlay on Roads and Bridges - 80 - General - 800 - Other Expenditure - State's Expenditure - KO - Special Project for attending Road Safety - 416 - Major works - 01 - Major works.

- 7. The Chief Engineer (H), Construction and Maintenance is directed to initiate land acquisition process even for works which do not specifically mention land acquisition in the nomenclature works if the Land is necessary and relates to the Road Safety works covered for all division Rs.150.00 Crore for 1502 number of works indicated in the annexure.
- 8. The Chief Engineer (H), Construction and Maintenance is authorized to incur the expenditure for the works sanctioned in para 5 above also to make changes in the nomenclature of works, if any, without exceeding the total cost of the work, subject to obtaining prior approval of the Government in Highways and Minor Ports Department.
- 9. The expenditure sanctioned in para 5 above shall constitute an item of "New Instrument of Service" and the approval of the Legislature will be obtained in due course. The Chief Engineer (Construction and Maintenance), Highways Department is directed to send necessary draft explanatory notes for the inclusion of the above expenditure in the Final Supplementary Estimates for the year 2020-2021 to Finance (BG-I/PWD-I Department at the appropriate time without fail. The Chief Engineer (Construction and Maintenance), Highways Department is authorized to incur the above expenditure only after obtaining approval from the Legislature.
