ORDER:-

In the Government Order first read above, as recommended by the Empowered Committee orders were issued for Creation of one post of Accounts Officer in the scale of pay of Rs.56,900-1,80,500 (Level-23) and Chief Accounts Officer in the scale of pay of Rs.59300-1,87,700 (Level-25) in Chennai–Kanyakumari Industrial Corridor project and permitted to fill up these posts through promotion/transfer of existing staff to the extent feasible and practicable from Finance Department/such other related departments or through outsourcing on contract basis or through procurement of services."

- 2.In the letter second read above, the Project Director, Chennai-Kanyakumari Industrial Corridor Project has requested orders of the Government to fill up the post of "Accounts Officer" in level 22 in Project Implementation Unit, Chennai Kanyakumari Industrial Corridor Project instead of level 23 as issued in G.O.(MS) No.144, Highways and Minor Ports (HS2) Department, dated 26.11.2019.
- 3. In the circumstances, explained by the Project Director, Chennai-Kanyakumari Industrial Corridor Project the Government after careful examination, accept the proposal of the Project Director, Chennai-Kanyakumari Industrial Corridor Project Chennai and issue the following amendment by substituting the paragraph 8 of G.O.(Ms). No. 144, Highways and Minor Ports (HS2) Department, dated: 26.11.2019 as follows:-

"The Government after careful examination accept the proposal of the Project Director, Chennai - Kanyakumari Industrial Corridor Project as

recommended by the Empowered Committee and accord sanction for Creation of the post of Accounts Officer in the scale of pay of Rs.56,100–177500 (Level-22) and Chief Accounts Officer in the scale of pay of Rs.59300 – 1,87,700 (Level-25) . The Project Director (Highways), Chennai - Kanyakumari Industrial Corridor Project is permitted to fill up these posts through promotion/ transfer of existing staff to the extent feasible and practicable from Finance Department/such other related departments or through outsourcing on contract basis or through procurement of services."
