ORDER:

During the Collectors' Conference 2011-2012, the Hon'ble Chief Minister has made an announcement that "Flyovers at Athupalam- Ukkadam in Coimbatore City will be constructed".

- 2. In the Government Order first read above, orders have been issued sanctioning a sum of Rs.1.00 Crore for the preparation of Detailed Project Report for the construction of flyovers at Athupalam-Ukkadam and Western Ring Road / Bypass road in Coimbatore city. Accordingly, preparation of Detailed Project Report for the construction of flyover at Athupalam-Ukkadam Junction in Coimbatore City was entrusted to the Consultants.
- 3. In the Government Order second read above, orders have been issued to accord Administrative Sanction for the acquisition of land and shifting of utilities for the construction of flyover along Athupalam and Ukkadam Junction in Coimbatore City at a cost of Rs.88.61 Crore.

4. In the letter third read above, the Chief Engineer (C&M), Highways Department has stated that the land acquisition is meant mainly for the formation of service road. Necessary work front for the construction of flyover is available in all the two legs. The construction cost for the 1st tier is worked out to Rs.168.00 crores as detailed below:

1.	First level flyover	: Rs. 91,82,83,710
2.	Forming approaches, at grade road Improvements, protective works etc.	: Rs. 43,83,26,048
3.	LS Provisions for Electrification, Advertisement, escalation, labour Welfare fund, contingencies etc.	: Rs. 32,33,90,242
	Total	: Rs.168,00,00,000

- 5. The Chief Engineer (Construction and Maintenance) Highways Department has therefore requested the Government to accord Administrative Sanction for the "Construction of flyover along Athupalam and Ukkadam Junction upto Oppanakara Street in Coimbatore City" at a cost of Rs.168.00 crore.
- 6. The Government after careful examination of the proposal of Chief Engineer (Construction and Maintenance) and accord administrative sanction for a sum of Rs.121.82 Crore (Rupees One Hundred and Twenty One Crore and Eighty Two Lakhs only) for the Construction of Flyover along Athupalam and Ukkadam Junction upto Oppanakara Street in Coimbatore city.
- 7. The expenditure sanctioned in para-6 above shall be debited to the following Head of Account:-

"5054 – Capital Outlay on Roads and Bridges – 04 – District and Other Roads – 337 – Road Works – Schemes in the Twelfth Five Year Plan–II–State Plan – KC – Acquisition of Lands for bye passes" – 64 – Major Works.

8. The expenditure sanctioned in para 6 above is an item of "New Service". The approval of the Legislature will be obtained in due course. Pending approval of the Legislature, the expenditure may be initially met by drawal of an advance from the Contingency Fund. The Chief Engineer (Construction and Maintenance), Highways Department, Chennai is directed to calculate the actual amount required for the period upto next supplementary estimates and apply for sanction of the same as advance from the Contingency Fund to Finance (B.G.I) Department directly in Form 'A' appended to the Tamil Nadu Contingency Fund Rules, 1963 along with a copy of this order. Orders for sanction of an advance from the Contingency Fund will be issued from Finance (B.G.I) Department. He is also requested to send a draft explanatory notes for including the above expenditure in the Revised Budget Estimate 2016-2017/Supplementary Estimate 2016-2017 to Finance (BG-I) Department without fail.

9. This Order issues with the concurrence of Finance Department Vide its U.O. No. 16014/PW-I/2016, dated 04-03-2016 and Additional Sanction Ledger No.2567 (Two Thousand Five Hundred and Sixty Seven).
