ORDER:-

In the Government Order first read above, among others Government accorded administrative sanction for the engagement of consultants for preparation of Detailed Project Report for the work of "Construction of Road Over Bridge at km 18/4 of Srivilliputhur — Sivakasi — Virudhunagar — Aruppukottai — Thiruchuli— Narikudi — Parthibanur road in lieu of existing Level Crossing No.427 at Railway km 563/100-200 in between Sivakasi and Srivilliputhur Railway Stations" to a sum of Rs.23.50 Lakhs.

2. In the letter second read above, the Chief Engineer (Projects), Highways Department has stated that the proposed Road Over Bridge is located at Satchiyapuram area of Sivakasi Town under Sivakasi constituency. Srivilliputhur to Sivakasi road is an important State Highways road. The road links Sivakasi with National Highways (NH-744) at Srivilliputhur which is connecting with Thirumangalam and Kollam. Sivakasi is an Industrial town with a large number of fireworks and printing Industries. As the area beyond the level crossing towards Sivakasi is the location for many industries, schools and colleges, the workers and students finds very difficult to reach their destination during peak hours. The alignment of the proposed Road Over Bridge has been approved by the alignment committee on 07.07.2014. The entire length of the alignment falls on the existing State Highways road. The alignment starts at Km 18/2016 of Srivilliputhur - Sivakasi - Virudhunagar - Aruppukottai - Thiruchuli-Narikudi - Parthibanur Road (SH-42), crosses the railway line with an angle of crossing 77.87 at ch.359.186m and ends at Km 19/006 of SH-42. The land acquisition for the Road Over Bridge alignment falls on Sivakasi Town (76.00 sgm) and Anaiyur (2861.50 sqm) Revenue Villages. Similarly, the Land Alienation area is 595 sqm for Sivakasi Town (7.00 sqm) and Anaiyur (588.00 sqm) respectively. The total land acquisition area is 2937.50 sqm. The Land Plan Schedule has been submitted to Virudhunagar collectorate on 26.05.2017. Necessary compensation for acquiring lands, structures, trees any other assets attached have to be paid for project affected owners as per latest prevailing land acquisition rules and acts. Accordingly, the Land Acquisition estimate has been prepared for an area of 2937.50 sqm for payment of compensation as per latest rules in force to an amount of Rs.23.25 Crores.

- The Chief Engineer (Projects), Highways Department has therefore requested the Government to accord administrative sanction for Land Acquisition for the above work for an amount of Rs.23.25 Crores.
- 4. The Government after careful examination, accept the proposal of the Chief Engineer (Projects), Highways Department and accord administrative sanction for a sum of Rs.23.25 Crore (Rupees Twenty Three Crore and Twenty Five lakh only) for carrying out Land Acquisition of 2937 Sq.m. for the work of "Construction of Road Over Bridge at km 18/4 of Srivilliputhur Sivakasi Virudhunagar Aruppukottai Thiruchuli Narikudi Parthibanur road in lieu of existing Level Crossing No.427 at Railway km 563/100-200 in between Sivakasi and Srivilliputhur Railway Stations".
- 5. The expenditure sanctioned in para-4 above shall be debited under the following head of account:-

5054 capital outlay on Roads and Bridges - 03. State Highways - 101. Bridges - State's Expenditure - JG Construction of over and under bridges in lieu of Existing level crossings - 464. Lands - 01. Lands - Voted.

6. The expenditure sanctioned in Para-4 above shall constitute an item of "New Instrument of Service" and the approval of the Legislature will be obtained in due course. The Chief Engineer (Projects), Highways Department is directed to send necessary draft explanatory notes to include the above expenditure in the Supplementary Estimates for the year 2020-2021 to Government in Finance (BG-I/PW-I) Department at the appropriate time without fail.

7.The Chief Engineer (Projects), Highways Department is authorized to incur the expenditure sanctioned in para 4 above.
