### ORDER:

The Chief Engineer (Construction and Maintenance), Highways Department in his letter read above has stated that, it is enumerated that 30000 PCU is passing through National Highways road in Pollachi town limits. The new two lane proposal is estimated to carry at least 1/3<sup>rd</sup> of traffic. This will definitely ease the congestion on the town limits. The classification of roads and the distance covered is tabulated as below:-

2. The Chief Engineer (Construction and Maintenance), Highways Department has stated that the District Collector, Coimbatore has recommended the proposal to hand over the roads to Highways Department. The above bypass proposal passes through existing roads (State Highways, Other District Roads and Union Roads), for which no land acquisition is needed.

3. The Chief Engineer (Constructions and Maintenance) Highways Department has therefore requested the Government to accord Administrative Sanction for the work of "Forming Eastern Bypass to Pollachi town starting from Thippampatty @ km 111/4 of NH 209 and ending Achipatty @ km 124/8 of NH 209 (via) Alampalayam, Rasakkapalayam, Kullakkapalayam to a length of 15.40 km" at a cost of Rs. 25.00 crore.

4. The Government after careful examination, has reworked/ modified the cost and accord Administrative Sanction for a sum of Rs.20.63 crores (Rupees Twenty Crores and Sixty Three Lakhs Only) towards the work of "Forming Eastern Bypass to Pollachi town starting from Thippampatty @ km 111/4 of NH 209 and ending Achipatty @ km 124/8 of NH 209 (via) Alampalayam, Rasakkapalayam, Kullakkapalayam to a length of 15.40 km.

5. The expenditure sanctioned in para-4 above shall be debited to the following Head of Account:-

"5054 – Capital Outlay on Roads and Bridges – 04 – District and Other Roads – 337 – Road Works – Schemes in the Twelfth Five Year Plan– II–State Plan – KC – Acquisition of Lands for bye passes" – 16 – Major Works.

6. The expenditure sanctioned in para 4 above is an item of "New Service". The approval of the Legislature will be obtained in due course. Pending approval of the Legislature, the expenditure may be initially met by drawal of an advance from the Contingency Fund. The Chief Engineer (Construction and Maintenance), Highways Department, Chennai is directed to calculate the actual amount required for the period upto next supplementary estimates and apply for sanction of the same as advance from the Contingency Fund to Finance (B.G.I) Department directly in Form 'A' appended to

the Tamil Nadu Contingency Fund Rules, 1963 along with a copy of this order. Orders for sanction of an advance from the Contingency Fund will be issued from Finance (B.G.I) Department. He is also requested to send a draft explanatory notes for including the above expenditure in the Revised Budget Estimate 2016-2017/Supplementary Estimate 2016-2017 to Finance (BG-I) Department without fail.

7. This Order issues with the concurrence of Finance Department Vide its U.O.No. 16066/PW-I/2016, dated 04-03-2016 and Additional Sanction Ledger No.2575 (Two Thousand Five Hundred and Seventy Five).
