ORDER

In the letter read above the Chief Engineer (Metro) Highways Department has stated that, Administrative Sanction and Revised Administrative Sanction for land acquisition for the "Formation of Tambaram Eastern Bye-pass road km.0/0-8/4 has been accorded for a sum of Rs.100.00 lakhs and Rs. 7550.49 lakhs vide G.O. (Ms) No. 264, HW&MP (HW1) Department, dated 23.09.2004 and G.O.(Ms) No.104, HW&MP(HP2) Department, dated 26.08.2015 respectively and the land acquisition is in progress. In the stretch of above said Bye-pass road km.0/850-3/900 have already been formed during 2013 in the existing alignment of Agraramthen road.

2. In the mean time, the Hon'ble Chief Minister has made the following announcement in the Legislative Assembly while moving the Grant No.21 of the Highways and Minor ports Department for the year 2017-18.

Based on the above announcement, the Chief Engineer (Metro), Highways Department has now furnished the proposal for the work of "Formation of Tambaram Eastern Bye-pass road branching from Km 17/4 of Marmalong bridge- Irumbuliyur road from Rajakilpakkam (via) Agaramthen road towards Perungalathur in the land acquired stretch of Km 5/450- 8/080". The Chief Engineer (Metro) has stated that the Land Acquisition process in one of the three villages in stretch of Tambaram Eastern Byepass at Km 5/450- 8/080 namely Thiruvancheri has been completed and 19(3) permission

has been sent to Commissioner of Land Administration for approval for Nedunkundram Part-I and part II.

4. The Chief Engineer (Metro) has stated above said proposal is Technically Approved as follows:

The Chief Engineer (Metro), Highways Department has therefore requested the Government to accord the necessary Administrative Sanction for **Rs.34.00 crore** for the work of "Formation of Tambaram Eastern Bye-pass road branching from Km 17/4 of Marmalong bridge- Irumbuliyur road from Rajakilpakkam (via) Agaramthen road towards Perungalathur at Km 5/450-8/080", (Land Acquisition completed portion only)" for taking up the same in the financial year 2017-18.

The Government, after detailed examination accepts the proposal of the Chief Engineer (Metro), and accord Administrative Sanction for a sum of Rs.33,35,62,844/-(Rupees Thirty three crore thirty five lakhs sixty two thousand eight hundred and forty four only) for "Formation of Tambaram Eastern Bye-pass road branching from km.17/4 of Marmalong Bridge —Irumbuliyur road from Rajakilpakkam (via) Agaramthen road towards Perungalathur at km 5/450-8/080 as follows:-
