ORDER:-

In the Government Order first read above, a consolidated Notification was issued incorporating the port limits of all the existing Minor Ports in Tamil Nadu.

2. In the letter second read above, the Vice Chairman & Chief Executive Officer, Tamil Nadu Maritime Board has informed that the M/s. Poompuhar Shipping Corporation Limited has proposed to extend the ferry operations en route up to Vattakottai tourist spot in Kanyakumari (without berthing) to attract the tourists. Based on the resolution of the Board of Tamil Nadu Maritime Board the Vice Chairman and Chief Executive Officer, Tamil Nadu Maritime Board has requested the Government to issue amendment to modify the existing port limits of the Kanyakumari Port and also to notify the modified port limits of Kanyakumari Port in Kanyakumari District under the provisions of the Indian Ports Act, 1908 (Central Act XV of 1908) and to issue an amendment to G.O.(Ms)No.110, Highways & Minor Ports (HN2) Department, dated 18.06.2009 and Tamil Nadu Government Gazette Notification dated 22.07.2009.

3. The Government have examined the proposal of the Vice Chairman and Chief Executive Officer, Tamil Nadu Maritime Board and decided to accept it and accordingly approve the Notification for extension of Port limits of Kanyakumari Port in Kanyakumari District under the provisions of the Indian Ports Act, 1908 (Central Act XV of 1908) as appended to this order.

4. The Notification appended to this order will be published in an extra-ordinary issue of the Tamil Nadu Government Gazette and in the Kanyakumari District Gazette.

5. The Vice Chairman and Chief Executive Officer, Tamil Nadu Maritime Board is requested to ensure the publication of the Notification appended to this order in the Kanyakumari District Gazette.
