ORDER:

In the Government order first read above, Government accorded administrative sanction for Rs. 951 Crore towards acquisition of 174.656 hectares of private land and transfer of 70.60 hectares of Government land in 15 Villages of Ponneri Taluk in Thiruvallur District for Northern Port Access Road Project.

2. In the Government order second read above, orders were issued constituting a Empowered Committee, under the Chairmanship of Hon'ble Minister for Highways and Minor Ports and in the Government order fourth read above orders were issued for utilizing the above committee for Chennai Peripheral Ring Road Project also. 3.The Project Director (H), Tamil Nadu Road Sector Project-II, Chennai-Kanyakumari Industrial Corridor (FAC) and Chennai Peripheral Ring Road in his letter fifth read above has stated that the empowered committee in its meeting held on 13.08.2018 has approved the following Resolution:-

"Approved the proposal of Project Director to proceed with Alignment Option of extending Chennai Outer Ring Road (CORR) upto TPP Link.

Approved the proposal of Project Director to proceed with the Land acquisition in the revised/modified alignments utilising the administrative sanction accorded for Land Acquisition vide G.O.(Ms).No.33, Highways and Minor Port (HF2) Department, dated 19.02.2016 and G.O (Ms) No.74, Highways and Minor Ports (HW2) Department, dated 09.05.2018 and also to send a consolidated revised proposal to the Government later subject to condition that the expenditure shall be restricted to the sanctioned amount."

- The Project Director (H), Tamil Nadu Road Sector Project-II, Chennai-Kanyakumari Industrial Corridor Project (FAC), Chennai Peripheral Ring Road has requested the orders of the Government in this regard.
- 5.The Government after careful examination accept the proposal of the Project Director (H), Tamil Nadu Road Sector Project-II, Chennai-Kanyakumari Industrial Corridor Project (FAC), Chennai Peripheral Ring Road and based on the decision taken by the Empowered Committee, the Government authorize the Project Director (H), Tamil Nadu Road Sector Project-II, Chennai-Kanyakumari Industrial Corridor Project (FAC), Chennai Peripheral Ring Road to proceed with the Land Acquisition in the revised / modified alignment utilizing the administrative sanctioned amount accorded for Land Acquisition vide G.O.(Ms).No.33, Highways and Minor Port (HF2) Department, dated 19.02.2016 and G.O.(Ms) No.74, Highways and Minor Ports (HW2) Department, dated 09.05.2018. The Project Director (H), Tamil Nadu Road Sector Project-II, Chennai-Kanyakumari Industrial Corridor Project (FAC), Chennai Peripheral Ring Road is also requested to send a consolidated revised proposal to the Government subject to condition that the expenditure shall be restricted to the sanctioned amount."
