### ORDER:

In the letter first read above, the Managing Director, State Industries Promotion Corporation of Tamil Nadu Limited has requested permission for taking up Detailed Project Report (DPR) for the work of "Formation of approach road from Kavarapettai – Sathyavedu road (SH52) to SIPCOT Industrial park, Manallur" as a deposit work from SIPCOT at a cost of Rs.10.00 lakh.

2. In the letter second read above, the Chief Engineer (H), Construction and Maintenance has stated that the Detailed Project Report (DPR) for "Formation of approach road to Kavarapettai – Sathyavedu road (SH-52) to SIPCOT Industrial Park, Manallur" including land acquisition" and SIPCOT have prepared LPS and the alignment plan for the approach road and it has been instructed to conduct a joint inspection with SIPCOT officials.

- 3. The Chief Engineer (H), Construction and Maintenance has stated that a joint inspection was conducted by Highways Department on 23.01.2020 along with the SIPCOT officials to finalize the Alignment proposal for approach road including land acquisition. The alignment was verified in the field. It was found that a portion of the alignment runs in an abandoned gravel quarry field which has deep excavations and hence it shall be modified at this portion only. Also the approach road starts at Km 14/4 of Kavarapettai-Sathyavedu Road (SH-52) and ends at Km 12/2 of Gummidipoondi Madarpakkam Road (MDR) and junction improvements at both ends has to be provided as per IRC standards and LPS to be revised accordingly.
- 4. In this regard, the SIPCOT, Managing Director has now requested to send the detailed estimate including acquisition of land, as developmental activities have been taken up in SIPCOT Industrial Park, Manallur. The revised alignment and LPS are to be prepared and communicated by the SIPCOT to the Divisional Engineer Thiruvallur, Highways Department based on the minutes of the joint inspection meeting and based on it Detailed Project Report (DPR) will be prepared by Highways Department.
- 5. The Chief Engineer (H), Construction and Maintenance has also stated that for preparation of DPR by Highways Department, an estimate is prepared with the provision for O&D survey at 2 locations, 7 days traffic volume studies, soil sample collection and conducting CBR test, design of pavement kilometer wise, design of junction improvements, drain retaining wall etc and submission of relevant reports with necessary drawings and power point presentations. The estimate for DPR is finalized for Rs.10.00 lakh. The revision in alignment & LPS by SIPCOT will not affect the preparation of DPR.
- 6. The Chief Engineer (H), Construction and Maintenance has therefore requested the Government to issue orders for obtaining a deposit of Rs 10.00 lakh from SIPCOT for proceeding with the DPR preparation work so as to commence the work early without delay.
- 7.The Government has requested the Chief Engineer (H), Construction and Maintenance to obtain permission from the Managing Director, State Industries Promotion Corporation of Tamil Nadu Limited for the deposit of Rs.10.00 lakh for proceeding with the Detailed Project Reports for the preparation work.
- The Chief Engineer (H), Construction and Maintenance has now informed that the Managing Director, SIPCOT, Thirvallur has given the concurrence of acceptance for depositing Rs.10.00 lakh for the above work.
- 9. The Chief Engineer (H), Construction and Maintenance has therefore requested the Government to issue necessary permission for obtaining a deposit of Rs.10.00 lakh from SIPCOT for proceeding with the Detailed Project Report (DPR) preparation work so as to commence the work early.
- 10. The Government after careful examination accept the proposal of the Chief Engineer (H), Construction and Maintenance and accord permission for obtaining a deposit of Rs.10.00 lakh from SIPCOT for proceeding with the Detailed Project Report (DPR) preparation work so as to commence the work early.

- 11. On completion of the Detailed Project Report, necessary Utilisation Certificate for the actual expenditure incurred may be furnished to SIPCOT and any savings may be returned back to SIPCOT.
- 11. This order issues with the concurrence of Finance Department vide its U.O.No14/JS/GKT/Finance (Ind)/2021, dated 04.08.2021.
