## ORDER:-

In the Government order first read above, orders were issued constituting a Committee consisting of representatives of Finance Department, Highways and Minor Ports Department, Director General and concerned Chief Engineers of Highways Department for scrutiny of Revised Administrative Sanction proposals.

2) In the Government order second read above, administrative sanction was accorded for "Construction of Flyover along Athupalam and Ukkadam junction upto Oppanakara Street in Coimbatore City including widening and improvements of diversion roads (Kuniyamuthur-Sundakkamuthur road and Km 164/0 of Salem-Cochin road to Sundarapuram (via) Machampalayam" for an amount of Rs.121.82 crores and Technical Sanction for Rs.127.90 crores has been accorded for this work.

- 3) The Chief Engineer (Construction and Maintenance) Highways Department in her letter third read above has stated that the Revised Administrative Sanction is required for the above work on account of the following reasons:-
  - Excess amount due to tender premium Rs.12,58,67,655
  - Amount increase due to Additional Quantity and Additional items Nil
  - Due to round off, the Net Excess Amount in Lumpsum Provision Rs.32,345
  - Excess amount due to the variation between AS & TS amount Rs.6,08,00,000
- 4) The committee on Revised Administrative Sanction in its meeting held on 27.08.2018 has approved the following proposal of Chief Engineer (Construction and Maintenance) Highways Department:-

5) The Government after careful examination accept the proposal of the Chief Engineer (Construction and Maintenance) Highways Department and approve Revised Administrative Sanction amounting to Rs.140.49 crore (Rupees One hundred and forty crores and forty nine lakhs only) for the work of "Construction of Flyover along Athupalam and Ukkadam junction upto Oppanakara Street in Coimbatore City including widening and improvements of diversion roads (Kuniyamuthur-Sundakkamuthur road and Km 164/0 of Salem-Cochin road to Sundarapuram (via) Machampalayam)" as recommended by the Revised Administrative Sanction Committee.
