### **ORDER:**

In the Government order first read above, the Government approved the Notification under Sub-section (1) of Section 15 of the Tamil Nadu Highways Act, 2001 (Tamil Nadu Act 34 of 2002) submitted by the District Revenue Officer, Trichirappalli for the acquisition of dry lands measuring to an extent of 0.5104.5 sq.mts of Ryot Dry/Government Dry and Royat Manai lands in Thimmarayasamuthram Village and Jambukeswaram village for the Reconstruction of ROB at Km 314/10 of Chennai-Trichy-Dindigul Road (Old NH-45 Near Thiruvanaikovil) in lieu of existing Old Bridge No.380A at Railway Km 329/8-9 between Trichirappalli & Srirangam Railway Stations was approved and the same was published in the Tamil Nadu Government Gazette second read above. Now, the District Revenue Officer, Trichirappalli in his letter third read above has sent Amendment proposal to the Government order and the notification published under Notification No.II(2) HWMP/236/2017 at Pages 318-328 in Part-II-Section 2 of the Tamil Nadu Gazette No.15, dated 12.04.2017 and requested to approve the same.
