1. G.O. (Ms) No. 119, Highways and Minor Ports (HQ2) Department, dated 30.11.2016.
2. From the Chief Engineer (Projects), Highways Department, Letter No.4486/W2/2016, dated 16.07.2018 and 22.01.2019.

ORDER:-

In Government Order first read above, among others, Government accorded Administrative Sanction for a sum of Rs.100.20 Lakhs for the preparation of Detailed Project Report through engaging consultants for construction of Road Over Bridges in lieu of existing Level Crossing Nos.91, 92, 95 and Road Under Bridge in lieu of Level Crossing No.28 under Railway Works Programme 2016-2017 on Cost sharing basis.

2. In the letters second read above, the Chief Engineer (Projects), Highways Department has stated that preparation of Detailed Project Report for the above works are in progress. In order to process the acquisition of land for the above works, the Land Plan Schedule was prepared and sent to the District Revenue Officer, Vellore as per the Tamil Nadu Highways Act, 2001 and Right to Fair Compensation and Transparency Act in Land Acquisition, Rehabilitation and Resettlement Act 2013. The process of acquisition of lands are under progress through Revenue Department. Necessary compensation for acquiring lands, structures, trees and other assets if any have to be paid for the Project affected land owners as per prevailing Land Acquisition Acts. The preparation of Land Plan Schedule and Land Acquisition estimates is a part of Detailed Project Report and necessary Administrative Sanction for Land Acquisition is required as first stage to complete the Land Acquisition process to commence the Road Over Bridge work early. On completion of the Detailed Project Report, the Administrative Sanction proposals for work will be sent soon.

3. The Chief Engineer (Projects), Highways Department has therefore requested the Government to accord Administrative Sanction for the amount

mentioned against the following each work for carrying out Land Acquisition:

4. The Government after careful examination, accept the proposal of the Chief Engineer (Projects), Highways Department and accord administrative sanction for acquisition of land for the following four works for a sum of Rs.6,32,53,000/- (Rupees Six Crore Thirty Two Lakh and Fifty Three Thousand only) under Railway Works Programme 2016-2017 on cost sharing basis, as mentioned against each work:-

The Government also sanction a sum of Rs.10,00,000/- (Rupees Ten Lakhs only) for the year 2020-2021 and the balance amount will be sanctioned in the next financial year based on needs.

5. The expenditure sanctioned in para-4 above shall be debited under the following head of account:-

6. The expenditure sanctioned in para 4 above shall constitute an item of "New Instrument of Service" and approval of the Legislature will be obtained in due course. Pending approval of the Legislature, the expenditure will be initially met by an advance from the contingency Fund. The Chief Engineer (Projects), Highways Department is directed to calculate the actual amount required for the period upto next supplementary estimates and apply for sanction of the same as advance from the Contingency Fund to Finance (B.G-I) Department directly in from 'A' appended to the Tamil Nadu Contingency Fund Rules, 1963 along with a copy of this order. Orders for sanction of an advance from the Contingency Fund will be issued from Finance (B.G-I) Department. The Chief Engineer (Projects), Highways Department is also directed to send a draft explanatory notes for inclusion the above expenditure in the supplementary estimates 2020-2021 to Finance (BG-I) Department without fail.
