#### **ORDER:**

In the Government order first read above, orders were issued for constituting a Committee consisting of representatives of Finance Department, Highways and Minor Ports Department, Director General and Concerned Chief Engineers' of Highways Department for scrutiny and Review of the Revised Administrative Sanction proposals.

In the Government order second read above, orders have issued for according Administrative Sanction for an amount of Rs.25.00 Crore for the work of " Widening from four lane to six lane and providing paver block end to end and construction of storm water drain in Km 17/9-21/2 of Chennai – Chittoor – Bangalore Road (SHU 03)".

3. The Committee on Revised Administrative Sanction in its meeting held on 04.03.2020 has approved the following proposal of Chief Engineer (H), Construction and Maintenance, Chennai-25.

The Government after careful examination, accept the proposal of the Chief Engineer (H), Construction and Maintenance and accord Revised Administrative Sanction for an amount of Rs.29.31 Crore (Rupees Twenty Nine Crore and thirty one lakh only) for the work of "Widening from four lane to six lane and providing paver block end to end and construction of storm water drain in Km.17/9-21/2 of Chennai – Chittoor – Bangalore Road (SHU 03) as recommended by the Revised Administrative Sanction Committee, as against the Administrative Sanction amount of Rs.25.00 Crore (Rupees Twenty Five Crore only).
