ORDER:

In the Government Order first read above, orders have been issued according Administrative Sanction for a sum of Rs.200.00 Crore for the work of widening the Madurai Ring Road from double lane to four lane from Km 0/0-27/2 under BOT basis.

- 2. In the Government Order second read above, orders have been issued for taking up the work of widening the Madurai Ring Road to four lane by Tamil Nadu Road Infrastructure Development Corporation under BOT Toll using suitable Viability Gap Funding with the condition that the financing model will be with maximum 40%. Accordingly in the Government order third read above, orders were issued to allocate Viability Gap Fund of Rs.80.00 Crore as 40% of Administrative Sanction amount of Rs.200.00 Crore for this project.
- 3. The Chairman and Managing Director, Tamil Nadu Road Infrastructure Development Corporation has stated that the concession agreement for the above work has been executed between Tamil Nadu Road Infrastructure Development Corporation and M/s.Sri Balaji Tollways. The Concession period for this work is 20 years including construction period of 2 years. While commencing the project, the

concessionaire has requested for shifting of various utilities involved in the project road and submitted tentative cost of Rs.20.02 Crore. During the inspection, it was found that the shifting of line sewer/water line will seriously affect the day to day activities and suggested for joint inspection with Corporation Officials. Accordingly joint inspection was made and laying of new pipeline has been decided and the cost arrived at for shifting is Rs. 4,07,46,052/-

- 4. The Chairman and Managing Director, Tamil Nadu Road Infrastructure Development Corporation has further stated that as per the Agreement clauses 11.2 and 11.2.1, the Shifting of utilities has to be undertaken by the concessionaire in coordination with the utility shifting authorities and the cost shall be borne by the Authority. The Concessionaire has requested the Tamil Nadu Road Infrastructure Development Corporation to finalize the rate for shifting of utilities with a specific provision of 10% contractors overhead of the department estimate rate. The Independent Engineer has reviewed the estimate as per relevant provisions of Concession Agreement and certified for Rs.19,03,36,427/- which includes Supervision Charges of owning entity and overhead charges of 10% of the estimates rates and recommended Rs.18,03,36,427 since Rs.1,00,00,000/- was allocated in the DPR for shifting of utilities.
- 5. The Chairman and Managing Director, Tamil Nadu Road Infrastructure Development Corporation has stated that the recommendation of Independent Engineer was critically scrutinized by Tamil Nadu Road Infrastructure Development Corporation and decided that, as the work of shifting utilities of TNEB has been almost completed and providing new water mains / lines of TWAD and Thirupparankundram panchayat can be taken up at the cost of estimate rate itself, the 10% over head charges on the departmental estimate rate need not to be considered. Accordingly, the total cost of shifting of utility has been arrived as detailed below by allowing 10% of contractor overhead charges for rerouting of sewer lines only.

6. The Chairman and Managing Director, Tamil Nadu Road Infrastructure Development Corporation has also stated that in addition to the above shifting of utilities, the Concessionaire has notified to the Independent Engineer about the damaged stretches towards the Tuticorin Port and to the Southern most parts of Tamil Nadu vise versa in addition to the routine traffic, for which, submitted an estimate for Rs.2.74 Crore for maintaining the project road to safe and traffic worthy condition. The Independent Engineer has verified and determined the cost as Rs.90,46,987/- which has been accepted by the Concessionaire also as per the existing agreement.

- 7. The Chairman and Managing Director, Tamil Nadu Road Infrastructure Development Corporation based on the outcome of the 48th Board Meeting held on 27.12.2017 has requested the Government to accord additional grant for a sum of Rs.18,57,69,039/- towards shifting of utilities and for maintaining the project road by the authority (TNRIDC) before the appointed date for the work of widening the Madurai Ring Road from Double lane to four lane from km 0/0-27/2 (BOT-Toll) so as complete the project within the scheduled period of completion and also to maintain the project road by Tamil Nadu Road Infrastructure Development Corporation.
- 8. Based on the resolution of the Board of the Tamil Nadu Road Infrastructure Development Corporation, the Government after careful examination, accord additional grant for a sum of Rs.18,57,69,039/- (Rupees Eighteen Crore Fifty Seven Lakhs Sixty Nine Thousand and Thirty Nine Only) towards shifting of utilities and for maintaining the project road by the authority (TNRIDC) before the appointed date for the work of widening the Madurai Ring Road from double lane to four lane from Km 0/0-27/2 (BOT-Toll) and also to maintain the project road by Tamil Nadu Road Infrastructure Development Corporation.
- 9. The expenditure sanctioned in para 8 above shall be debited to the following head of account:

"5054-Capital Outlay on Roads and Bridges-03-State Highways -337-Road Works-State's Expenditure-JM-Widening to four lane of Madurai Ring Road through TNRIDC"-16 Major works.

10. The expenditure sanctioned in Para-8 above is an item of "New Instrument of Service". The approval of the Legislature will be obtained in due course. Pending

approval of the Legislature, the expenditure may be initially met by drawal of an advance from the Contingency Fund. The Managing Director, Tamil Nadu Road Infrastructure Development Corporation, Chennai-2 is directed to calculate the actual amount required for the period upto next supplementary estimates and apply for sanction of the same as advance from the Contingency Fund through the Chief Engineer (Construction & Maintenance), Highways Department to Finance (B.G-I) Department directly in Form 'A' appended to the Tamil Nadu Contingency Fund Rules, 1963 along with a copy of this order. Orders for sanction of an advance from the Contingency Fund will be issued from Finance (B.G-I) Department. He is also directed to send a draft explanatory notes for inclusion of the above expenditure in the Supplementary Estimates 2018-19 to Finance (BG-I) Department without fail.

11. This order issues with the concurrence of Finance Department vide its U.O.No. 20784/PW-I/2018 dated 14-05-2018 with Additional Sanction Ledger No.269 (Two Hundred and Sixty Nine).
