ORDER:-

The Chief Engineer (General), Highways Department in his letter second read above has stated that, the following 24 number of Assistant Engineers of Tamil Nadu State Construction Corporation Ltd. were deputed to the Rural Development and Panchayat Raj Department for want of vacancy as the Tamil Nadu State Construction Corporation Ltd. became a sick unit.

- 2. Consequent on their reversion from the Rural Development and Panchayat Raj Department they were appointed in Highways Department on deputation basis for the period of three years in G.O. first read above.
- 3. The Director General, Highways Department in his letter third read above, has stated that among the said 24 Assistant Engineers Tmt S.Suguna (Sl.No.24) was recruited as Assistant Engineer through the Tamil Nadu Public Service Commission (appointed in Highways Department on 10.01.2008) and the remaining 23 Assistant Engineers have been working in Highways Department and requested the Government to regularize the services of said 23 Assistant Engineers from the date of their joining in Highways Department (i.e 01.01.08). He has also stated that for the permanent absorption of the said 23 Assistant Engineers in Highways Department, the rule relating to age, reservation and the mode of appointment to be relaxed and relaxation of Educational qualification does not arise as all the 23 Assistant Engineers are already in possession of B.E. (Civil) qualification.
- 4. In the meantime, among the above 23 Assistant Engineers Thiru M.Ramamoorthy, Tmt K.Suganthi and Thiru P.Manibalan filed W.P.No.938, 939/2017 and 14907/2017 before the Hon'ble High Court of Madras for permanent absorption in the Highways Department as Assistant Engineers. The Hon'ble High Court

of Madras in its order dated 11.01.2017 in W.P.No.938, 939/2017 and the order dated 14.06.2017 in W.P.No.14907/2017 directed the first respondent (i.e Principal Secretary, Highways and Minor Ports Department, Government of Tamil Nadu, Fort St. George, Chennai-9) to act on the recommendation of fourth and third respondents (viz. the Managing Director, Tamil Nadu State Construction Corporation Ltd. and the Director General, Highways Department) in letter 37057/Nir2(1)/2007, dated 11.07.2011 and pass orders on merits in accordance with Law within a period of 6 weeks from the date of receipt of copy of the order. In the meantime, one of the petitioners Thiru M.Ramamoorthy filed a Contempt Petition No.1070/2017 before the Hon'ble High Court of Madras, in which the Hon'ble Court has given two weeks time to comply the orders passed by the Hon'ble High Court of Madras, dated 11.01.2017.

- 5. In the letter fourth read above, the Tamil Nadu Public Service Commission has accorded its concurrence under latter part 16(b) of Tamil Nadu Public Service Commission Regulations, 1954 for absorption of the 23 Assistant Engineers in Highways department who are on deputation from the Tamil Nadu State Construction Corporation Ltd. without conducting Special Qualifying Examination. Their seniority in Highways Department shall be fixed below the last regular incumbent appointed in the cadre of Assistant Engineers as on date.
- 6. After careful detailed examination of the proposal of the Director General, Highways Department and based on the concurrence of the Tamil Nadu Public Service Commission, the orders of the Hon'ble High Court of Madras dated 11.01.2017 in W.P.Nos.938, 939/2017 and the order dated 14.06.2017 in W.P.No.14907/2017 and to avoid contempt of Court, the Government accept the proposal of the Director General, Highways Department and order that the following 23 Assistant Engineers of Tamil Nadu State Construction Corporation Ltd. who worked earlier in Rural Development on contract basis and later reverted to Highways Department on deputation basis be absorbed permanently from the date of their joining in Highways Department (i.e. 01.01.2008) and their seniority is fixed below the last regular incumbent appointed in the cadre of Assistant Engineer as on date by relaxing the rules (i.e. age, method of appointments and rule of reservation) subject to the conditions issued in G.O (Ms) No.27, Finance (BPE) Department, dated 24.01.2007.

- 8. Consequent to the absorbtion of above 23 Assistant Engineers, they are eligible for monetary benefits, if any, with effect from the date of issue of order.
