NOTIFICATION

The Governor of Tamil Nadu having been satisfied that the lands specified in the Schedule below have to be acquired for Highways purpose to wit for Reconstruction of ROB at km 314/10 of Chennai - Trichy-Dindigul road (Old NH 45 Near Thiruvanaikoil) in lieu of existing Old Bridge No. 380A at Railway km 329/8-9 between Tiruchirappalli & Srirangam Railway Stations in Thimmarayasamuthiram Village and it has already been decided that the entire amount of compensation to be awarded for the lands is to be paid out of the funds controlled or managed by Divisional Engineer (Projects), Highways Department, Tiruchirappalli after considering the cause shown by the owner (or) other person having interest on such lands as the case may be do hereby publish the following Notice under sub-section (1) of section 15 of the Tamil Nadu Highways Act, 2001 (Tamil Nadu Act 34 of 2002).
