National Highways – Centrally Sponsored Scheme – Revamped Central Road Fund Scheme 2015-16 – Administrative sanction accorded by the Government of India, Ministry of Road Transport and Highways for 78 works – Financial sanction of the State Government – Accorded – Orders – Issued.

#### Read:-

1. From the Government of India, Ministry of Road Transport and Highways Letter No.RW/NH/12027/ 297/2012-TN/P-7, dated 14.05.2015.

2. From the Chief Engineer (National Highways) Letter No.2900/ VS2/NH/2015, dated 15.05.2015.

### **ORDER:-**

In their letter first read above, the Government of India, Ministry of Road Transport and Highways has accorded administrative approval for 78 works amounting to Rs.390.00 crore under the Revamped Central Road Fund Scheme 2015-16 and requested the State Government to accord financial and technical sanction for the individual works within a period of 4 months from the date of administrative approval, failing which the works shall deemed to have been de-sanctioned as per Central Road Fund Rules 2007.

- 2. The Government of India have also imposed the following conditions and following of e-procurement:-
  - (i) No additional fund in excess of the possible allocation of fund as per CRF Act 2000 would be allocated to the States/UT.
  - (ii) The Government of Tamil Nadu shall ensure that progress of works would not suffer due to delay in payments for want of additional funds under Central Road Fund.
  - (iii) Payment of bills in excess of possible allocation of funds as per CRF Act,2000, if needed, is to be temporarily arranged by the State Government.

- (iv) The stipulation made in Ministry's Circular letter No. NH-11011/2/2000-P&M(Pt), dated 08.08.2007 (Notification No.GSR 475-E, dated 10.07.2007) shall be strictly followed.
- (v) If the approved road merges with any National Highways, the detail of such junction/location shall be got approved from the Ministry/National Highways Authority of India before entrusting the work.
- (vi) The funds used for the project approved as per guidelines circulated to various State Government / UTs as per the Ministry's Letter No.RW/NH-11011/ 2/2000-P&M(Pt), dated 08.08.2007 (Notification No.GSR 475-E, dated 10.07.2007).
- (vii) Display boards should be erected on the sanctioned works.
- 3. The Chief Engineer (National Highways), Highways Department has therefore requested the Government to accord financial sanction for 78 works amounting to Rs.390.00 crore before the prescribed time limit (4 months) as per Central Road Fund Rules, 2007 to avoid de-sanction of the works approved by the Government of India under Revamped Central Road Fund Scheme 2015-16.
- 4. The Government after careful consideration, accept the proposal of the Chief Engineer (National Highways), Highways Department and accord administrative sanction of Rs.390.00 Crores (Rupees Three hundred and ninety crores) and also the financial sanction of Rs.241.3625 Crores (Two hundred and forty one crores, thirty six lakhs and twenty five thousand only) for 78 works (annexed to this order) under Revamped Central Road Fund Scheme for the year 2015-16.
- 5. The expenditure sanctioned in Para-4 above shall be debited to the following Head of Account:-
  - "5054 Capital Outlay on Roads and Bridges 80 General 800 Other expenditure Schemes in the twelfth five year plan II State Plan KA Revamped Central Road Fund 16 Major works. (DPC 5054-80-800-KA-1601)
- 6. Necessary additional funds of Rs.120,00 lakhs will be provided in Revised Estimate/Final Modified Appropriation 2015-16 to meet the expenditure sanctioned in Para-4 above. Pending provision of funds in Revised Estimate/Final Modified Appropriation 2015-16, the Chief Engineer (National Highways), Highways Department is authorized to incur the expenditure. However, this should be brought to the notice of the Legislative Assembly by specific inclusion in the Supplementary Estimates 2015-16. The Chief Engineer (National Highways), Highways Department shall include the expenditure sanctioned above while sending the Budget proposal for Revised Estimate/Final Modified Appropriation 2015-16 and also to send necessary Explanatory Notes for including the above expenditure in the Supplementary Estimates 2015-16 to Finance (BG.1/PW1) Department without fail.

- 7. The Chief Engineer (National Highways), Highways Department is directed to accord technical sanction for the works (annexed to this order) within a period of 4 months from the date of administrative approval of the works, failing which the works will be deemed to be deleted from the programme. In any case, the period of completion of the project should not exceed 24 months including periods for tendering. No revised estimates will be considered in this scheme at any cost.
- 8. The Chief Engineer (National Highways), Highways Department is directed to comply with the following conditions:
  - i) Furnish necessary particulars to Government of India in the prescribed format upon the technical sanction of estimates for all the works sanctioned from Central Road Fund under intimation to the State Government.
  - ii) Ensure that the conditions laid down by Government of India, Ministry of Road Transport and Highways as stated at Para-2 above are complied with while implementing the works.
  - iii) Ensure that the amount provided for Cental Road Fund works are restricted only to the schemes identified and approved by Government of India.
- 9. The Chief Engineer (National Highways), Highways Department is also directed to ensure that the sanctioned works are not included in any other scheme such as Tamil Nadu Road Sector Project, General Maintenance Works, Comprehensive Road Infrastructure Development Programme, Panchayat Union Schemes and etc.
- 10. The Chief Engineer (National Highways), Highways Department is also requested to furnish the Utilization Certificate along with quarterly progress report from the date of ending of each quarter and get the expenditure reimbursed from Government of India.
- 11. This order issues with the concurrence of Finance Department vide its U.O.No.13/DS(MA)/PW1/2015, dated 23.07.2015 and A.S.L.No.632 (Six hundred and thirty two).
