ORDER:

In the Government Order first read above, orders were issued according administrative sanction for an amount of Rs.22.00 Crores for Formation of Outer Ring Road for Erode Town (Land Acquisition).

2) In the Government Order second read above, orders were issued to constitute a committee for RAS consisting of representatives of Finance Department, Highways and Minor Ports Department, Director General and concerned Chief Engineers of Highways Department for scrutiny and review of the Revised Administrative Sanction proposals.

3) The Chief Engineer (H) (Projects) in his letter 3rd read above has requested the Government to approve the Revised Administrative Sanction for the work of "Formation of Outer Ring Road for Erode Town (Land Acquisition) for amount of Rs.49,97,00,000/- as recommended by RAS committee as detailed below:-

4) The Government after careful examination accept the proposal of the Chief Engineer (H) (Projects) and accord Revised Administrative Sanction for the work of "Formation of Outer Ring Road for Erode Town (Land Acquisition)" for an amount of Rs.49,97,00,000/- (Rupees Forty Nine Crores and Ninety Seven Lakhs only) as approved by the Revised Administrative Sanction committee as against the administrative sanctioned amount of Rs.22,00,00,000/-. The Government also sanction a sum of Rs.1,00,00,000/- (Rupees One Crore only) for the year 2020-2021 and the balance amount will be sanctioned in the next Financial year based on needs.

5) The expenditure sanctioned in para 4 above shall be debited to the following head of account:

"5054 – Capital Outlay on Road and bridges – 03 – State Highways – 337 – Road Works – State's Expenditure – JA – Original works – 464 – Lands – 01.Lands (voted)"

6) The Chief Engineer (C&M)/Projects, Highways Department is authorized to incur the expenditure sanctioned in para 4 above.

7) The expenditure sanctioned in para 4 above shall constitute an item of "New Instrument of Service" and approval of the Legislature will be obtained in due course. Pending approval of the Legislature, the expenditure will be initially met by an advance from the Contingency Fund. The Chief Engineer (C&M)/Projects, Highways Department is directed to calculate the actual amount required for the period upto next supplementary estimates and apply for sanction of the same as advance from the Contingency Fund to Finance (B.G.I) Department directly in Form 'A' appended to the Tamil Nadu Contingency Fund Rules, 1963 along with a copy of this order. Orders for sanction of an advance from the Contingency Fund will be issued from Finance (B.G.I) Department. The Chief Engineer (C&M)/Projects, Highways Department is also directed to send a draft explanatory notes for inclusion the above expenditure in the Supplementary Estimates 2020-2021 to Finance (B.G.I) Department without fail.

8) This order issues with the concurrence of Finance Department vide its U.O. No.20841/PW-I/2020, dated.15.07.2020 and Additional Sanction Ledger No.193 (One Hundred and Ninety Three).
