ORDER:

The Chief Engineer (Construction and Maintenance), Highways Department in his letters first read above has furnished the Detailed Project Report based on the current schedule of rates (2017-2018) for Rs.3179.00 Lakhs for the following 5 road works in Sivagangai and Krishnagiri Districts for taking up under State Infrastructure Amenities Fund for the year 2017-18.

4.	Widening from end to end at Km 0/0-1/3 and providing drain cum foot path in Km 0/0-1/3 of Hosur Town to Hosur Railway Station Road
5.	Improvements to the junction at Km 39/6 of Varanasi-Kaniyakumari road Hosur town limit

2) The Commissioner of Town and Country Planning in her letters second and third read above has stated that, the 16th meeting of the State Infrastructure

and Amenities Promotion Committee held on 14.2.2018 vide Agenda Nos.7 and 8, it was decided to sanction as follows:-

3) The Government after careful examination, accept the proposal of the Chief Engineer (Construction and Maintenance), Highways Department as approved by the State Infrastructure and Amenities Promotion Committee and accord Administrative Sanction for a sum of Rs. 3179.00 Lakhs (Rupees Three Thousand One Hundred and Seventy Nine Lakhs only) for the above mentioned 5 road works in Sivagangai and Krishnagiri Districts for taking up under State Infrastructure and Amenities Fund for the year 2017-18.

4) The expenditure sanctioned in Para 3 above shall be debited to the following head of account:

6) The expenditure sanctioned in para 3 above shall constitute an item of “New Instrument of Service” and the approval of the Legislature shall be obtained in due course of time by an inclusion in the Supplementary Estimates for the year 2018-19. Pending approval of the Legislature, the expenditure shall initially be met by drawal of an advance from the Contingency Fund. The Chief Engineer (Construction and Maintenance), Highways is directed to calculate the actual amount required for the period up to next Supplementary Estimates and apply for sanction of the same as advance from the Contingency Fund to Finance (BG-I) Department directly in Form “A” appended to the Tamil Nadu Contingency Fund Rules 1963 along with a copy of this order. Orders regarding this will be issued by the Finance (BG.I) Department separately. The Chief Engineer (Construction and Maintenance), Highways is directed to send necessary explanatory notes for inclusion of the above expenditure in the Supplementary Estimates for the year 2018-19 to Finance (BG-I/PW-I) Department at the appropriate time without fail.

7) The Chief Engineer (Construction and Maintenance) Highways is directed to send expenditure details to the Commissioner of Town and Country Planning for reconciling the Infrastructure and Amenities Fund with Accountant General at the end of Financial year.

8) The Chief Engineer (Construction and Maintenance) Highways is directed to incur the above expenditures within the sanctioned amount and there shall not be any Revised Administrative Sanction in the future.
