The Transport Commissioner / Road Safety Commissioner, Chennai in his letter first read above has stated that the Administration Officer, FAST, Monash University Accident Research Centre, Monash University, Australia has invited him to participate in the 2018 MUARC Conference held from 28.05.2018 to 01.06.2018 at Australia and requested him to make a diary note that a 'Welcome Reception' has been arranged for 5.00 P.M – 7.00 P.M Sunday 27th May at Bistro Guillaume, Southbank and this will give an opportunity to meet the MUARC Faculty and the Course Participants Prior to starting the program on Monday morning. He has further stated that he has applied to MUARC Road Safety leadership Program, May 2018. After accepting the Application for the course, Monash University requested him to pay AUD 9,900 towards course Fees.

The Project Director, Tamil Nadu Road Sector Project-II in his letter second read above has stated that, as per the RSELG direction, the World Bank has been requested to issue No objection for funding the proposed nomination of Thiru. C.Samayamoorthy, I.A.S., Transport Commissioner to attend the MUARC Road Safety Management Leadership Program – May 2018 from 28.05.2018 to 01.06.2018 at Melbourne in Australia. The tentative cost assessed for the above training program is Rs.9,50,000/- excepting the daily allowance which shall be claimed by the individual under their routine salary head.
