#### ORDER:

As per the orders issued in Government Order third read above, the ticket fare now collected from the passengers at Kanyakumari Ferry Service is as follows:-

Adult	Rs.34/-	(Tariff Rs.30 + applicable Service Tax Rs.4)
Student	Rs.17/-	(Tariff Rs.15 + applicable Service Tax Rs.2)
Special Visitors	Rs.169/-	(Tariff Rs.150+applicable Service Tax Rs.19)

2. The Poompuhar Shipping Corporation Limited pays establishment charges to Tamil Nadu Maritime Board at the rate of ₹1/- per ticket and Ayyan Thiruvalluvar Statue Maintenance charges to TTDC at the rate of Rs.5/- per ticket and GST presently @18% as follows:-

3) The Tamil Nadu Maritime Board is a regulating authority for running ferry service at Kanyakumari Port. Tamil Nadu Maritime Board is the statutory authority for inspecting, licensing the crafts conducting examinations, issuing certificates for Serang, Master manning the ferries, prescribing measures and ensuring the safety of passengers and supervising the ferry service etc., The Tamil Nadu Maritime Board have indicated that their establishment charges have steadily increased due to the revision of the pay for their employees, maintenance of statutory aspects etc., Hence, the Vice Chairman & Chief Executive Officer, Tamil Nadu Maritime Board in his letter fourth read above has requested to enhance the establishment charges payable to the Tamil Nadu Maritime Board from ₹1/- to 5% of the ticket fare applicable to all the categories of tourists.

4) In the letter fifth read above, the Principal Secretary / Chairman & Managing Director, Poompohar Shipping Corporation Limited has forwarded the proposal to revise the ticket fare of Kanyakumari Ferry Service duly considering the expected additional expenses likely to be incurred by the Corporation for operating ferry service viz., increase in salary cost, fuel cost, increase in cost of spares, maintenance of ferries, upkeeping of life saving appliances such as life jacket etc.,

The Government have examined the proposal of the Principal Secretary / Chairman & Managing Director, Poompohar Shipping Corporation Limited and the Vice Chairman & Chief Executive Officer, Tamil Nadu Maritime Board in detail and decided to accept it. Accordingly, the ticket fare of Kanyakumari Ferry Service for transportation of tourist from shore to Vivekananda Rock Memorial and Ayyan Thiruvalluvar Statue at Kanyakumari is revised and the establishment charges payable to Tamil Nadu Maritime Board is enhanced from ₹1 to 5% on Base price of the ticket fare plus applicable GST @18% as follows:-
