ORDER:

In the G.O. first read above, the Government has accorded administrative sanction for a sum of Rs.29,97,79,442/- (Rupees Twenty Nine Crore Ninety Seven Lakhs Seventy Nine Thousand Four Hundred and Forty Two only) to Guidance for Development of a comprehensive Single Window Portal, IT system Development and maintenance for improving Operation and Maintenance of IT systems relating to Ease of Doing Business at Guidance and also sanctioned a sum of Rs.9,88,74,505/- (Rupees Nine Crores Eighty Eight Lakhs Seventy Four Thousand Five Hundred and Five only) for the year 2020–21.

2. In the letter second read above, the Managing Director and Chief Executive Officer, Guidance has stated as follows:-

- i. As per the Administrative sanction issued in the G.O. first cited, a sum of Rs.3,52,37,262/- (Rupees Three Crores Fifty two lakhs Thirty Seven thousand Two hundred and Sixty two only) has been allocated to Guidance for the year 2022-2023. This amount has also been included in BE 2022-2023.
- ii. The Managing Director and Chief Executive Officer, Guidance has requested the Government to sanction and release the amount of Rs.3,52,37,262/- (Rupees Three Crores Fifty two lakhs Thirty Seven thousand Two hundred and Sixty two only) allocated to Guidance in BE 2022 – 23 under the head of account: '2852-80-800-JX implementation and maintenance of online systems for improving the "Ease of Doing Business" in Tamil Nadu' (DPC:2852 80 800 JX 30903) and to authorize the Industries Commissioner and Director of Industries and Commerce to draw and disburse the amount to Guidance Tamil Nadu at the earliest.

The Government, after careful examination, sanction a sum of Rs.3,52,37,262/- (Rupees Three Crores Fifty two lakhs Thirty Seven thousand Two hundred and Sixty two only) to Guidance for Development of a comprehensive Single Window Portal, IT system Development and maintenance for improving operation and maintenance of IT systems relating to Ease of Doing Business.

4. The expenditure sanctioned in paragraph 3 above, shall be debited to the following head of account:-
