ORDER:

In the letter first read above, the Joint Secretary, Department for Promotion of Industry and Internal Trade, Ministry of Commerce and Industry, Government of India has stated that the Department for Promotion of Industry and Internal Trade (DPIIT) has been made the nodal department for coordinating the exercise of minimizing regulatory compliance burden as it also coordinates 'Ease of Doing Business' and 'Global Competitiveness Index' which relate to compliance of different types across Ministries/ Departments. Decriminalization of minor offences is an important aspect of this exercise.

2. In the letter second read above, the Cabinet Secretary, Government of India has requested the State Government to draw up roadmaps for

decriminalization of various provisions in laws administered by the State and to constitute dedicated teams headed by senior level officers in relevant departments of the State for this purpose.

- 3. The Guidance in their email fourth read above, has stated that a steering committee headed by the Chief Secretary may be constituted to monitor the progress of the work done by all Heads of Departments to decriminalize provisions of imprisonment for minor violations within the time frame fixed by the Department for Promotion of Industry and Internal Trade, Government of India.
- 4. After careful examination, the Government hereby constitute a Steering Committee under the Chairmanship of Chief Secretary to Government to monitor the progress of work done by all Head of the Departments for decriminalization of various provisions in laws administered by the State as follows:-

Chairman 1. Chief Secretary to Government 2. Additional Chief Secretary to Government, Member Industries, Investment Promotion & Commerce Department Member 3. Additional Chief Secretary to Government, Labour Welfare and Skill Development Department Member 4. Additional Chief Secretary to Government, Municipal Administration and Water Supply Department Member 5. Secretary to Government, Law Department Member 6. Secretary to Government, Commercial Taxes and Registration Department

i. The Committee will monitor the progress of the work done by Heads of Departments in terms of preparing road maps for decriminalization, reviewing existing acts/ rules, identifying provisions that are to be removed, retained or decriminalized, preparing Bills for amendment of laws and seeking approval of Legislative Assembly.
