### AMENDMENTS TO NOTIFICATION

In exercise of the powers conferred by sub-section (1) of Section 34 of the Tamil Nadu Business Facilitation Act, 2018 (Tamil Nadu Act 7 of 2018), the Governor of Tamil Nadu hereby makes the following amendments to the Tamil Nadu Business Facilitation Rules, 2017.

AMENDMENTS

In the said Rules, -

(1) for rule 2, the following rule shall be substituted, namely:-

"2. Definitions .- In these rules, unless the context otherwise requires,-

(1) 'Acknowledgement' means the acknowledgement issued under these rules;

(2) 'Act' means the Tamil Nadu Business Facilitation Act, 2018 (Tamil Nadu Act 7 of 2018);

(3) 'Checklist' means the list of documents to be furnished by the applicant along with Combined Application Form;

(4) 'Clearance-specific application Form' means the Form prescribed by the concerned department delivering a notified service under the Act, from time to time;

(5) 'Form' means Form annexed with these rules;

(6) 'MSME' means Micro, Small and Medium Enterprises;

(7) 'Section' means section of the Act;

(8) words and expressions used herein but not defined in these rules shall have the same meanings assigned to them in the Act.";

(2) for the expression "Ordinance", wherever it occurs throughout the rules, the expression "Act" shall be substituted.
