ORDER:

In the letter first read above, the Managing Trustee, Chennai Mathematical Institute (CMI) has requested the Government to allot the Plot No.7/D7 measuring an extent of 3.78 acres of SIPCOT IT Park, Siruseri in order to expand their presence in Tamil Nadu and help to promote research, teaching and industry linkage. He has further stated that this plot is conveniently located to CMI and best suited for its expansion activities and he has requested to fix the cost of land including registration charges at a 50% subsidy rate.

2. In the note second read above, the Managing Director, State Industries Promotion Corporation of Tamil Nadu (SIPCOT) has recommended that as M/s. CMI, is a "not for profit" entity, their request for allotment of aforesaid plot at SIPCOT IT Park, Siruseri for expansion of their project may be considered at 50% (Subsidized) Industrial rate, i.e. Rs.247.50 lakhs per acre, subject to the Government's approval for reimbursement of the balance 50% amount to SIPCOT.

3. The Government have carefully examined the request of M/s. CMI and the recommendations of SIPCOT, and Government have decided to accept the request of M/s. CMI for allotment of Plot No.7/D7 measuring 3.78 acres at SIPCOT IT Park, Siruseri at 50% subsidized rate, i.e. Rs.247.50 lakh per acre, subject to the following conditions:-

- i. Chennai Mathematical Institute should undertake free of cost at least 10 research projects / studies that the Government assigns to them per year. Such assigned research projects/ studies be in the areas of CMI's specialization and shall not exceed 300 hours per year for upto five years. For anything above the 300 hours per year, CMI will bring in partners to whom the Government can pay directly.

- ii. Chennai Mathematical Institute should provide training to Government staff / university staff (about 200 in a year) for course of about 2 weeks duration, free of cost, as and when such training requests are made.
- iii. Government of Tamil Nadu will nominate a representative to the Board of trustees of CMI.
- iv. The land shall be used only for the stated purpose.

4. The Government shall contribute an appropriate sum to the Industrial Ecosystems Fund. The Government further direct SIPCOT and CMI to enter into a legally-binding MoU containing the conditions mentioned at para-3 above and the transfer of the land shall take place only upon signing of the MoU.

5. The Managing Director, SIPCOT and M/s. CMI are requested to take necessary further action.

6. This order issues with the concurrence of Finance department vide its U.O.No.10726/BPE/22, Finance (BPE) Department, dated 07.03.2022.
