#### **ORDER:**

In the G.O.  $1^{\rm st}$  read above, Government issued orders for implementation of the Tamil Nadu Electronics Hardware Manufacturing Policy, 2020.

- 2. In the G.O.  $2^{\rm nd}$  read above, Government issued orders for implementation of the Tamil Nadu Industrial Policy, 2021.
- 3. In the reference 2<sup>nd</sup> read above, Managing Director and Chief Executive Officer, Guidance has proposed amendments to Tamil Nadu Electronics Hardware Manufacturing Policy, 2020 regarding Governance Mechanism, Districts classification and Standard investment period as per Tamil Nadu Industrial Policy, 2021.
- 4. The Government after careful examination of the proposal hereby issue the following amendments to Tamil Nadu Electronics Hardware Manufacturing Policy, 2020:
  - i. The existing Table of district classification under Clause I of Section 2 of Administration of Incentives in Tamil Nadu Electronics Hardware Manufacturing Policy, 2020 shall be deleted and replaced with the following:

# "Classification of districts:

For the purpose of administering State level incentives, classification of districts in the State shall be as per Tamil Nadu Industrial Policy, 2021".

ii. Under Clause II of Section 2, Administration of Incentives, the following paragraph shall be added:

"Standard Investment Period" of 4 years for Large and Mega categories as per Tamil Nadu Industrial Policy, 2021 shall be applicable to projects under Tamil Nadu Electronics Hardware Manufacturing Policy, 2020.

iii. The existing para under Clause III, Governance Mechanism of Section 2, Administration of Incentives in Tamil Nadu Electronics Hardware Manufacturing Policy, 2020, "The incentives for Large and Mega Industries shall be sanctioned by the Industries Department and the Structured package shall be sanctioned as per the recommendation of the Inter Departmental Committee (IDC) convened by the Industries department and the related incentives will be disbursed by SIPCOT", shall be replaced as follows:

"The incentives as per this policy for Large and Mega Industries shall be sanctioned based on the proposal of Guidance to eligible industries by the Industries Department in concurrence with Finance Department. Under special circumstances, the Cabinet may sanction customized package for Large/Mega projects beyond the Policy based on the recommendations of the Inter Departmental Committee (IDC) convened by the Industries Department. The existing institutional mechanism for disbursal of investment related incentives to industries and other implementation guidelines (as per Tamil Nadu Industrial Policy, 2021 or the prevailing industrial policy) shall be applicable to the industries eligible under this Policy."
