ORDER:

In the G.O first read above, the Government have sanctioned Rs.1,00,00,000/- for providing centre median opening at KM 50/4 of Rajiv Gandhi Salai along with improvement works to widen the existing carriage way for additional 7m width on both sides of the median to a minimum weaving length of 100m on either direction, provision of traffic signals and cautionary information boards, etc., for heavy vehicular movement for M/s.OneHub Chennai Pvt Ltd.

- 2. The above sanctioned amount was not utilized by the Highways Department within the financial year 2021-2022. The total amount has been surrendered by Industries Commissioner and Director of Industries and Commerce in the FMA II for the year 2021-2022.
- 3. In the letter third read above, the Chief Engineer (Highways), Construction and Maintenance has stated that the above work is implemented by the Divisional Engineer (H) construction and Maintenance, Chengalpet Division and the work is under progress in full swing and it is nearing completion. An allocation of Rs.100 lakhs is required for the payment of pending bills. Therefore, he has requested the Government that necessary Budget allocation of Rs.100 lakhs for the year 2022 2023 may be provided and the fund may be remitted in the following Bank Account for early completion of the sanctioned work.

The Government, after careful examination, sanction Rs.1,00,00,000/-(Rupees One Crore only) through Industries Budget to the Divisional Engineer (H), Construction and Maintenance, Chengalpet Division for providing centre median opening at KM 50/4 of Rajiv Gandhi Salai along with improvement works to widen the existing carriage way for additional 7m width on both sides of the median to a minimum weaving length of 100m on either direction, provision of traffic signals and cautionary information boards, etc., for heavy vehicular movement for OneHub Chennai Pvt Ltd.
- 5. The expenditure sanctioned in paragraph 4 above, shall be debited to the following head of account:-
 - "4875. Capital Outlay on other Industries 60. Other Industries 190 Investments in Public Sector and Other Undertakings States' Expenditure JI Infrastructure Development for Industries 416 Major Works 01. Major Works" (IFHRMS DPC:4875-60-190-JI 416 01)
- 6. Necessary additional funds of Rs. 1,00,00,000/- will be provided in RE/FMA 2022-2023 to meet the expenditure sanctioned in para 4 above. However, this expenditure shall be brought for the notice of the Legislature by Specific Inclusion in the Supplementary Estimate 2022-2023. Pending provision of such funds, the Industries Commissioner and Director of Industries and Commerce is authorized to draw and disburse the amount sanctioned in para 4 above to the Divisional Engineer (H), Construction and Maintenance, Highways Department, Chengalpet Division to the following account:-
